1. Leichhardt Draft Development Control Plan 2013

Leichhardt Council has prepared a *Draft Development Control Plan (DCP) 2013*. The *Draft DCP* is on public exhibition from Monday 24th June 2013 until Wednesday 31st July 2013 and during this period Council would like to obtain as much feedback as possible.

The *Draft DCP* applies to virtually every property within the Local Government Area and outlines detailed planning and design guidelines for particular types of development. The *Draft DCP* involves a written document with illustrations, diagrams, photos and maps. The plan supports Council's exhibited *Draft Leichhardt Local Environmental Plan 2012*.

The *Draft DCP* is made according to the requirements of the *Environmental Planning and Assessment Act 1979*. Recent changes to this legislation required Council to consolidate its 12 existing DCP's into one comprehensive DCP.

2. Amendments to Exhibited Draft Leichhardt Local Environmental Plan 2012

At the Council Meeting held on the 21st May 2013 Leichhardt Council determined it appropriate to modify parts of the exhibited *Draft Leichhardt Local Environmental Plan (LEP) 2012.*

Council resolved (C202/13) to:

- Advise the NSW Department of Planning and Infrastructure of the changes required to the Draft LEP; and
- Initiate the changes to the Draft LEP with the NSW Department of Planning and Infrastructure via a Planning Proposal process.

The changes to the exhibited *Draft LEP* are as follows:

- (i) Changes to the Aims of Plan and Zone Objectives
- (ii) Amendments to Clause 4.3A Landscaped Area for residential development in Zone R1
- (iii) Inclusion of new subclause 4.4B Exceptions to maximum floor space ratio for non-residential development and subsequent amendments to Floor Space Ratio maps
- (iv) Amendments and additions to the Land Use Tables
