I am writing to submit the Council Land Reclassification (Housekeeping) Planning Proposal (PP) for Gateway Determination under Section 56 of the Environmental Planning and Assessment Act 1979 (EP&A Act). The PP has been prepared in accordance with Section 55 of the EP&A Act and sets out the objectives, intended outcomes and justification for the proposal.

Please find attached letter requesting Gateway Determination for Council Land Reclassification (Housekeeping) Planning Proposal.

The PP aims to extinguish Council's interest in land at Shoalhaven Heads, Coolangatta, St Georges Basin and part of land at Vincentia, and to reclassify the remainder of the Vincentia land from "operational" to "community".
