Planning Proposal 6 – Gateway Determination extension

I refer to emailed correspondence between Council's Mr Ian Rankine, Senior Strategic Planner, and Ms Louise Wells of my office regarding an extension of time to complete Planning Proposal No. 6 (PP_2013_SHELL_002_00), which updates Mineral Resource and Transition Area mapping in the Shellharbour Local Environmental Plan 2013.

I understand that the above Planning Proposal (PP) has been exhibited, however there are delays in finalising the PP as a result of ongoing discussions with NSW Trade and Investment regarding the final maps; and competing priorities for limited staff resources, given other PPs being dealt with by Council at this time.

The Gateway Determination for the above PP, issued on 18 July 2013, identified a 9 month timeframe for completion of the LEP, which expired on 25 April 2014.

I have determined as the delegate of the Minister, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway Determination to extend the time for the completion of the LEP by 6 months. The LEP is now due for finalised by 25 October 2014. Please see attached Amending Gateway Determination.
