#### Planning proposal to amend Wingecarribee Local Environmental Plan 2010

I am writing in response to your Council's request for a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to rezone land at 53 Bowral Street and 444, 446 and 448 Moss Vale Road, Bowral from B4 Mixed Use to R3 Medium Density Residential, apply a minimum lot size of 700sqm and remove floor space ratio and maximum building height controls for the subject land.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

I note that Council proposes to apply a 700sqm minimum lot size to land at Bowral Street and Moss Vale Road, Bowral. Given the proposed zoning is for medium density residential purposes, Council is encouraged to consider reducing the minimum lot size applicable to the subject land. If Council supports the above approach, it is to amend the planning proposal and associated maps accordingly prior to undertaking public exhibition.

I have also agreed the planning proposal's inconsistency with S117 Direction 1.1 Business and Industrial Zones is of minor significance. No further approval is required in relation to this Direction.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

## **Gateway Determination**

**Planning proposal (Department Ref: PP\_2013\_WINGE\_008\_00)**: to rezone and amend the development controls for land at Bowral.

I, the Acting Deputy Director General, Planning Operations and Regional Delivery at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Wingecarribee Local Environmental Plan (LEP) 2010 to rezone land at 53 Bowral Street and 444, 446 and 448 Moss Vale Road, Bowral from B4 Mixed Use to R3 Medium Density Residential, apply a minimum lot size of 700sqm and remove floor space ratio and maximum building height controls for the subject land should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, Council is to update the planning proposal to include existing and proposed land zoning, lot size and other applicable maps, which are at an appropriate scale and clearly identify the subject lands.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
  - (a) the planning proposal is classified as low impact as described in *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013)* and must be made publicly available for a minimum of **14 days**; and
  - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013).*
- 3. No consultation is required with public authorities under section 56(2)(d) of the EP&A Act.
- A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
