PLANNING PROPOSAL

LOCAL GOVERNMENT AREA: WINGECARRIBEE SHIRE COUNCIL

ADDRESS OF LAND: Various sites throughout the Shire.

SITE DESCRIPTION

This Planning Proposal relates to 86 sites in the towns, villages and localities of Avoca, Berrima, Bong Bong, Bowral, Bundanoon, Burradoo, Burrawang, Exeter, Glenquarry, High Range, Hill Top, Kangaloon, Mittagong, Moss Vale, Penrose, Renwick, Robertson, Sutton Forest, Wildes Meadow and Wingello.

PART 1 - OBJECTIVES OR INTENDED OUTCOMES OF PLANNING PROPOSAL

The primary purpose of the Planning Proposal is to add 84 new heritage items to the Environmental Heritage schedule of the Wingecarribee Local Environmental Plan (WLEP) 2010. However the Planning Proposal also amends two other items in the heritage schedule and removes a further item listed in error.

PART 2 – EXPLANATION OF PROVISIONS

The provisions of the Planning Proposal will amend Wingecarribee Local Environmental Plan 2010 to add 84 new heritage items to the Environmental Heritage Schedule (Schedule 5 of the WLEP 2010). The new heritage items also require amendments to the suite of Heritage Maps that form part of the WLEP 2010.

The majority of the new heritage items are of local significance and have been the subject of a heritage study where their listing was recommended by the heritage consultants who undertook the study. However, there are two items to be added to the heritage schedule that have been listed on the State Heritage Register since the WLEP 2010 was published on 16 June 2010, and two further listings (which relate to the same item but in two parts of the heritage schedule) are to be amended in line with another recent State Heritage Register listing.

The Planning Proposal also includes one (1) existing heritage item to be removed from the heritage schedule. This item is not of heritage significance and was included in the WLEP 2010 in error.

The <u>Appendix</u> to this document contains the list of all heritage items to be added, amended and deleted. Each of these additions, amendments and deletions requires a corresponding amendment to one of more of the Heritage Maps. The map sheet/s to be amended is/are noted in the Appendix beside each item.

PART 3 - JUSTIFICATION

There are three different types of justification for the items the subject of this Planning Proposal: new heritage items recommended in a heritage study, new heritage items that have been added to the State Heritage Register, and a deletion from the heritage schedule. Each of these is discussed in the table below.

Section A – Need for the Planning Proposal

1. Is the Planning Proposal the result of any strategic study or report?

The new proposed heritage items are all the subject of a resolution of Council from 28 November 2012 as a result of a recommendation from a heritage consultant and/or advisor to be listed as a heritage item, largely as part of the Wingecarribee Heritage Survey Project.

2. Is the Planning Proposal the best means of achieving the objectives or intended outcomes, or is there a better way?

The Planning Proposal is the only mechanism available to ensure ongoing protection of items of heritage significance.

Section B – Relationship to strategic planning framework

3. Is the Planning Proposal consistent with the objectives and actions contained within the applicable regional or sub-regional strategy (including draft strategies)?

The Sydney–Canberra Corridor Regional Strategy is the relevant regional strategy for the Wingecarribee Shire. One of the parts of the Strategy is to "protect the cultural and Aboriginal heritage values and visual character of rural towns and villages and surrounding landscapes" (p. 13). The listing of new items helps to fulfil the following Cultural Heritage Action from the Strategy:

• Councils and the Department of Planning will review the scope and quality of the existing statutory lists of heritage items and ensure that all places of significance are included in the heritage schedules of local environmental plans. (p. 50)

This Planning Proposal will ensure that the intended outcomes of preserving cultural heritage and improved management and recording of heritage information can be met.

4. Is the Planning Proposal consistent with a council's local strategy or other local strategic plan?

The Planning Proposal is consistent with Wingecarribee Our Future 2002 Strategic Plan and the Wingecarribee Community Strategic Plan 2031+. The recognition, protection and recording of places of heritage significance are important aspects of both of these plans.

5. Is the Planning Proposal consistent with applicable State Environmental Planning Policies?

There are no relevant SEPPs for this Planning Proposal.

6. Is the Planning Proposal consistent with applicable section 117 Directions?

The following s.117 Directions apply.

Section C - Environmental, social and economic impact

There will be no adverse environmental, social or economic impacts resulting from this Planning Proposal. The heritage listing of a property can assist in providing a sounder economic base to sustain its ongoing maintenance and preservation.

8. Are there any other likely environmental effects as a result of the Planning Proposal and how are they proposed to be managed?

There are no other adverse environmental impacts resulting from this Planning Proposal.

9. Has the Planning Proposal adequately addressed any social and economic effects?

It is considered that the Planning Proposal has adequately addressed the social or economic effects resulting from its implementation. The heritage listing of a property can assist in providing a sounder economic base to sustain its ongoing maintenance and preservation.

Section D – State and Commonwealth interests

10. Is there adequate public infrastructure for the Planning Proposal?

This proposal is not considered to be of a scale that would affect public infrastructure.

11. What are the views of State and Commonwealth public authorities consulted in accordance with the Gateway Determination?

Public authority consultation will occur through the exhibition period as required in the Gateway Determination.

PART 4 – MAPPING

No map amendments have been prepared at this stage. Those properties which are to be heritage listed for the first time will be identified on the relevant Heritage Maps and the list of the items in the Appendix indicates the map sheet or sheets on which each new/amended item will appear. A set of maps will be prepared to form part of the public exhibition during the community consultation phase of the Planning Proposal and Council requests the Department of Planning and Environment to assist in this regard.

PART 5 – COMMUNITY CONSULTATION

It is recommended that the Planning Proposal be publicly exhibited for a period of 28 days.

Council intends to place the Planning Proposal on public exhibition by advertising on Council's page in the Southern Highland News and making the Planning Proposal and supporting material available on Council's website as well as in the three key libraries within the Shire – Mittagong, Bowral and Moss Vale. Relevant heritage groups and local community groups will also be advised.
