

Gateway Determination

Planning proposal (Department Ref: PP_2015_EUROB_001_00): to make various housekeeping and other amendments to the Eurobodalla LEP 2012.

I, the Deputy Secretary, Planning Services at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the Eurobodalla Local Environmental Plan 2012 to correct a number of omissions and anomalies from the Local Environmental Plan Maps, clauses, land use tables and Local Environmental Plan Schedules should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, the planning proposal is to be updated to:
 - (a) remove all reference to the R2 Low Density Residential Zone for land located at Coronation Drive, Broulee. This land is to be zoned E4 Environmental Living zone; and
 - (b) include the context maps as prepared by Council (9 March 2015) and mapping that clearly illustrates the flood affectation for Lots 9 and 10 DP 1174944, Lot 1 DP 125321 and Lot 21 DP 1077474.

Note: Maps should be prepared to the standards identified in Standard Technical Requirements for LEP Maps (Department of Planning and Environment 2013).

- 2. Community consultation is required under sections 56(2)(c) and 57 of the Act as follows:
 - (a) the planning proposal must be made publicly available for a minimum of 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing Local Environmental Plans (Department of Planning and Environment 2013).
- 3. Consultation is required under section 57 of the Act, with the following public agencies prior to exhibition:
 - Office of Environment and Heritage; and
 - NSW Rural Fire Service (s117 Direction 4.4 Planning for Bushfire Protection).

Each public agency is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal. This agency advice received and the proposed response to this advice should be placed on public exhibition with the planning proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).

- 5. The Secretary can be satisfied that the planning proposal will be consistent with section 117 Direction 4.4 (Planning for Bushfire Protection) once the Council has consulted with the NSW Rural Fire Service prior to community consultation and taken into account and comments received.
- 6. The timeframe for completing the LEP is to be 12 months from the week following the date of the Gateway determination.

Planning proposal to amend Eurobodalla Local Environmental Plan 2012

I am writing in response to Council's letter dated 3 December 2014 requesting a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal to amend Eurobodalla Local Environmental Plan 2012 to correct a number of omissions and anomalies from the Local Environmental Plan Maps, clauses, land use tables and Local Environmental Plan Schedules.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to variations as outlined by the conditions in the attached Gateway determination.

It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

However, please note that the inconsistency with section 117 Directions 2.1 Environmental Protection Zones and 4.3 Flood Prone Land have not been approved. Once the work required to justify this inconsistency has been completed, Council should make a submission to the Department seeking this approval. This must occur prior to finalisation of the amendment.

The amending Local Environmental Plan is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the Local Environmental Plan should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.
