## Eurobodalla Local Environmental Plan 2012 (Amendment No 7)

1 Name of Plan

This Plan is Eurobodalla Local Environmental Plan 2012 (Amendment No 7).

#### 2 Commencement

This Plan commences on the day on which it is published on the NSW legislation website.

#### 3 Land to which Plan applies

This Plan applies to:

- (a) the land to which Eurobodalla Local Environmental Plan 2012 applies, and
- (b) the land to which clause 30D of *Eurobodalla Rural Local Environmental Plan* 1987 applies, and certain land at Central Tilba and Tilba, and
- (c) the land to which Eurobodalla Urban Local Environmental Plan 1999 applies.

#### 4 Maps

The maps adopted by *Eurobodalla Local Environmental Plan 2012* are amended or replaced, as the case requires, by the maps approved by the Minister on the making of this Plan.

#### 5 Amendment of Eurobodalla Rural Local Environmental Plan 1987

(1) Clause 30D Prohibition on dual occupancy development—Kyla Park Estate Omit the clause.

#### (2) Schedule 1 Environmental heritage

## Schedule 1 Amendment of Eurobodalla Local Environmental Plan 2012

#### [1] Land Use Table

Insert "Home-based child care;", "Home businesses;", "Home industries;" and "Secondary dwellings;" in alphabetical order in item 3 of Zone R3 Medium Density Residential.

#### [2] Land Use Table, Zone B5, item 3

Insert "Plant nurseries;" in alphabetical order.

#### [3] Land Use Table, Zone IN1, item 3

Insert "Bulky goods premises;" in alphabetical order.

#### [4] Land Use Table, Zone E2, item 3

Insert "Camping grounds;" and "Roads;" in alphabetical order.

#### [5] Clause 3.3 Environmentally sensitive areas excluded

Omit paragraph (ja) from the definition of *environmentally sensitive area for exempt or complying development* in clause 3.3 (2).

#### [6] Clause 4.2A Erection of dwelling houses or dual occupancies on land in Zone RU1 Primary Production

Omit the definition of *1987 holding* from clause 4.2A (5). Insert instead:

*1987 holding* means land that:

- (a) was a holding on 11 December 1987, and
- (b) is a holding at the time the application for development consent referred to in subclause (2) is lodged,

whether or not there has been a change in the ownership of the holding since 11 December 1987, and includes any other land adjoining that land acquired by the owner or owners since 11 December 1987.

**Note.** The owner in whose ownership all the land is at the time the application is lodged need not be the same person as the owner in whose ownership all the land was on the stated date.

#### [7] Clause 6.16 Development of land at Kyla Park

Omit "2 hectares" from clause 6.16 (3). Insert instead "lot".

#### [8] Schedule 1 Additional permitted uses

Insert after clause 15:

#### 15A Use of certain land at Wharf Street, Nelligen

- (1) This clause applies to the following parcels of land at Nelligen:
  - (a) the parcel of land comprising 1 Wharf Street, being Lot 15, Section 6, DP 758762,
  - (b) the parcel of land comprising 3, 5, 7 and 9 Wharf Street, being Lots 11–13, Section 6, DP 758762, Lot 1, DP 125591 and Lot 1, DP 1038903,
  - (c) the parcel of land comprising 11 Wharf Street, being Lot 10, Section 6, DP 758762,

- (d) the parcel of land comprising 13 and 15 Wharf Street, being Lots 8 and 9, DP 571676,
- (e) the parcel of land comprising 17 and 19 Wharf Street, being Lots 6 and 7, Section 6, DP 758762.
- (2) Development for the purposes of a single dwelling house (and any associated bed and breakfast accommodation, health consulting rooms, home-based child care, home business, home industry or secondary dwelling) is permitted with consent on each of the parcels of land specified in subclause (1).

Omit "Place". Insert instead "Parade".

[10] Schedule 2 Exempt development

Omit all matter relating to Advertisements.

[11] Schedule 3 Complying development

Omit the matter relating to Industrial buildings and warehouses (external alterations or additions) from Part 1.

Omit "Lot 29, DP 13566" from item no I35 in Part 1. Insert instead "Lot 1, DP 1194082".
