Gateway Determination Extension for Shoalhaven Planning Proposal PP_SHOAL_2014_002_00 Heritage Estates and Elouera and Fairview Estates

I refer to Planning Proposal (PP_2014_SHOAL_002_00) which rezones land in the Heritage Estates and adjoining Elouera and Fairview Estates from RU2 Rural Landscapes to E2 Environmental Conservation in the Shoalhaven Local Environmental Plan 2014.

I am aware that the above proposal has been exhibited and adopted by Council. I note that as a result of the outstanding Federal Court case on Heritage Estates, Council has split the proposal into two separate Local Environmental Plan amendments.

I would like to congratulate Council on having the Elouera and Fairview Estates Local Environmental Plan Amendment (Shoalhaven Local Environmental Plan 2014 Amendment No. 3) notified on 24 October 2014. This amendment reflects the high biodiversity values of the land and will remove any uncertainty about the future uses and zoning of the land.

I understand that the Heritage Estates Local Environmental Plan Amendment is ready to be submitted to the Parliamentary Counsel's Office, once the Federal Court judgement is made in mid November 2014.

The Gateway determination for the planning proposal, issued on 11 February 2014, identified a 9 month timeframe for completion of the Local Environmental Plan, expiring on 11 October 2014.

I have determined, as the delegate of the Minister, in accordance with section 56(7) of the Environmental Planning and Assessment Act, 1979, to amend the Gateway determination to extend the time for the completion of the Local Environmental Plan by a further 6 months. The Local Environmental Plan is now due to be finalised by 11 April 2015. Please see the attached Alteration of Gateway determination.
