PURPOSE

The purpose of this report is to consider requests by two separate not-for-profit community based organisations to prepare a Planning Proposal to amend Wingecarribee Local Environmental Plan 2010 (WLEP 2010) as follows:

- <u>Moss Vale Showground Trust</u> amend WLEP 2010 to enable Camping Ground at Moss Vale Showground, No 18-46 Robertson Road, Moss Vale - Lot 1 DP738800 and Lots 4 and 5 DP6103.
- <u>Robertson & District Swimming Pool Association Inc</u> amend WLEP 2010 to allow a Recreation Facility (indoor) on Australian Rail Track Corporation (ARTC) Land at the Cnr of Caalong and Congewoi Streets, Robertson (No Lot or DP description).

- 3. <u>THAT</u> the applicants be informed of Council's decision.
- 4. <u>THAT</u> the Robertson & District Swimming Pool Association Inc be invited to attend an Information Session for Councillors to outline their proposal for the Recreation Facility (Indoor).
