At the Ordinary Council meeting held on the 20 July 2016 Council resolved to forward a Planning Proposal to the NSW Department of Planning to affect certain deferred matters over

This Planning Proposal will have the following outcomes;

- Make minor amendments to the BVLEP 2013 zoning maps which have been found to be in error;
- Make minor amendments to the BVLEP 2013 heritage maps which have been found to be in error;
- To add four (4) heritage items the Hotel Australasia in Eden, the Eden Ocean Swimming Pools & the Old Bega Racecourse Grandstand - which have been suggested by community members and endorsed by Council in March 2014 and July 2016;
- To add an additional land use to facilitate existing uses by adding the definition of 'restaurants and cafes' to the land use table at the Business 1 Zone (B1) - Neighbourhood Centres - Clause 2.3 (3);
- To increase the definition of floor space of a 'kiosk' from 20m² to 50m²; Clause 5.4(6);
- To add an additional land use 'information and educational facilities' to the Medium Density Residential Zone (R3). This matter was prompted by Eden Killer Whale Museum Committee which is considering an expansion of the current facility on to adjoining land. Currently a museum is prohibited in the R3 zone. *Clause 2.3 (3).*

Council requests a Gateway Determination on the Planning Proposal from the Minister for Planning in accordance with Section 56 of the *Environmental Planning and Assessment Act 1979*. As such, please find enclosed a copy of the Council resolution and Planning Proposal report for your reference.

As this matter is of local significance, we are seeking delegation of the plan-making functions under Section 59 of the Environmental Planning and Assessment Act 1979. This delegation will be to the position of General Manager, and sub-delegated to the position of Group Mapserment of Planning Planning and Environment. The NSW Department of Planning Evaluation Criteria for the Environment Delegation of Plan Making Functions is attached to this Proposal. RECEIVED
