Re: Leichhardt Local Environmental Plan 2013 – Amendment 2 Extension of Gateway Determination Timeframes Submission of Revised Planning Proposal for Amendments to Clause 4.3A (Landscaped Provisions)

Background

Leichhardt Local Environmental Plan (LEP) 2013 Amendment 2 includes the following planning proposal items:

- 1. Amendments/additions to Aims of Plan and Zone Objectives:
- 2. Amendments to Clause 4.3A Landscaped Provisions Landscaped areas for residential accommodation in Zone R1;
- 3. Inclusion of new subclause 4.4B Exceptions to maximum floor space ratio for nonresidential development and subsequent amendments to Floor Space Ratio maps;
- 4. Amendments/additions to Land Use Tables:
- 5. Inclusion of Complying Development Controls for the installation of photovoltaic panels; and
- 6. Rezoning 55 Justin Street, Lilyfield from IN2 Light Industrial to B7 Business Park.

Gateway Determination Timeframes

On 21 June 2013 Council received the Gateway Determination for Items 1, 2, 3, 4 and 5 and on 14 June 2013 Council received the Gateway Determination in relation to Item 6 (Rezoning of 55 Justin Street, Lilyfield). In both instances Council was advised that the timeframe for completion of the amendments to the Leichhardt LEP 2013 (Amendment 2) was nine (9) months from the date of the Gateway Determinations. This means that the amendments were due to be completed as follows:

- 21 March 2014 Items 1, 2, 3, 4 & 5. •
- 14 March 2014 Item 6 Rezoning of 55 Justin Street, Lilyfield.

The Gateway Determinations also issued authorisations for Council to exercise delegation from the Minister of Planning and Infrastructure to make the amendments to the Leichhardt LEP 2013 (Amendment 2).

Public Exhibition

The amendments were on exhibition for a period of 38 days from 24 June 2013 to the 31 July 2013.

Council considered the following reports on the outcomes of public exhibition on the 24 September 2013:

- Item E14 Amendments to Draft Leichhardt LEP 2013 Public Exhibition.
- Item E15 Supplementary Report to address late submission in relation to *Draft Development Control Plan 2013* and amendments to *Draft Leichhardt LEP 2013* dealt with in conjunction with Item E14.

On 24 September 2013 Council resolved (C432/13) to:

- adopt the proposed amendments outlined in the planning proposals Items 1, 2, 3, 4 and 6;
- not proceed with the proposed amendment outlined in planning proposal item 5 as it was inconsistent with State Environmental Planning Policy Infrastructure 2007 and could not be legally made; and
- delegate authority to the General Manager to finalise the amendments and ensure that the legal drafting by Parliamentary Counsel is consistent with this resolution of Council.

Legal Drafting and Post Exhibition Changes Proposed to Clause 4.3A

On 2 October 2013, pursuant to the resolution of 24 September 2013 (C432/13) Council requested that Parliamentary Counsel prepare a draft instrument under section 59(1) of the *Environmental Planning and Assessment Act 1979.*

The content of Amendment 2 has now been finalised with the exception of Item 2 (amendments to Clause 4.3A), at the request of Council. This has occurred because it was found when applying the draft Clause 4.3A that it is not an accurate translation of Clause 19(3) of *Leichhardt LEP 2000*. Council has therefore reviewed and redrafted Clause 4.3A in the context of the published *Leichhardt LEP 2013* and *Development Control Plan 2013* to ensure that Clause 4.3A more closely reflects the provisions of *LEP 2000* whilst being consistent with the provisions of the Standard Instrument.

Council advised Parliamentary Counsels Office that it would seek advice from Planning and Infrastructure on the proposed modifications to the draft Clause 4.3A before proceeding to finalise Amendment 2.

Extension of Gateway Determination Timeframes and Revised Planning Proposal for Amendments to Clause 4.3A

On 8 April 2014 Council considered a report on the status and progress of Amendment 2 and a revised planning proposal for amendments to Clause 4.3A. In the report it was noted that Council requires an extension of time to complete Amendment 2. The report and resolution (BDC72/14) are attached.

In accordance with this resolution (BDC72/14), Council:

- requests an extension to the Gateway Determinations timeframes for Amendment 2 to the *Leichhardt LEP 2013*; and
- submits a revised planning proposal for amendments to Clause 4.3A Landscaped areas for residential accommodation in Zone R1 (Attachment 5 to report) in accordance with section 58(1) of the *Environmental Planning and Assessment Act* 1979.

Deferment of Amendments to Clause 4.3A from Leichhardt LEP 2013 Amendment 2

Council prefers that community consultation be required for the revised planning proposal for amendments to Clause 4.3A. If the revised Gateway Determination under section 56 of the *Environmental Planning and Assessment Act 1979* reflects that preference it is proposed that the General Manager:

- defer the inclusion of amendment to Clause 4.3A Landscaped areas for residential accommodation in Zone R1 in the *Leichhardt LEP 2013 (Amendment 2)* in accordance with section 59(4) of the *Environmental Planning and Assessment Act 1979*;
- exhibit the revised planning proposal for Clause 4.3A in accordance with Council's community engagement plan and any requirements of the Gateway Determination; and
- finalise *Leichhardt LEP 2013 (Amendment 2)* with Parliamentary Counsel and Planning and Infrastructure and ensure that any technical and legal requirements are met.
