Re: Lot 24 Warrah Road, North Nowra – Hollow Bearing Tree Survey

Dear Sir,

Please find below the following report referring to Hollow Bearing Tree surveys undertaken on the 6th and 7th of January and the 14th February, 2011 at Lot 24 Warrah Road, North Nowra.

Background

Biosis Research was commissioned by Southbank Lands Pty. Ltd. and Huntingdale Developments Pty. Ltd. to undertake a comprehensive Hollow Bearing Tree (hereafter 'HBT') survey to inform rezoning investigations of Lot 24, DP 714096 (Subject Site), North Nowra in the Shoalhaven Local Government Area (LGA). The Study Area of this survey includes the Subject Site and a 5m buffer. These surveys follow flora and fauna surveys carried out by Biosis Research in April 2010 (Biosis Research 2010) which documented the occurrence of numerous HBTs in both the Open Woodland and Open Forest habitats of the Subject Site. Alison Hunt and Associates surveyed a portion of the Subject Site in 2008 (AHA 2008) and also documented a number of HBTs.

The Subject Site, just under 74ha, is currently zoned for rural use. Further to the current zoning of the Subject Site, Shoalhaven City Council (SCC) has prepared a revised draft Local Environmental Plan 2009 (DLEP 2009) according to the 'Standard Instrument' gazetted by the NSW Government in 2006. The Subject Site is being investigated by the land owners to determine what parts are suitable for residential development with the remainder to be zoned environmental.

Field Methodology

A structured parallel-line foot-based traverse of the Subject Site was undertaken by two zoologists on the 6th and 7th January 2011, and again on the 14th February 2011, to search for HBTs and to assess their potential for fauna occupancy.

During the 46 person hours of survey effort, a significant area of the Subject Site was covered (Figure 1). Survey effort was focused on areas supporting significant habitat features with a representative sample of vegetation communities across the site being surveyed. Areas of grassland and shrubland in the eastern portion of the Subject Site, subject to clearing historically, were not surveyed due to a lack of canopy trees. Other areas of long-range visibility, such as in the south-west corner and parts of the north-western arm, there was no need to survey as it was possible to determine whether trees had hollows from a distance.

HBTs were inspected for viable hollows using a pair of 10x42mm binoculars. Recently fallen limbs and branches were also inspected to obtain further information on the viability of hollows. All dead and alive HBTs observed were recorded where they met the following criteria:

- Hollow entrance visible
- Hollow appears to have depth
- Hollow appears to be at least 1 metre above the ground.

Information gathered on each potential HBT included:

- Tree status (i.e. living or dead);
- Diameter at Breast Height (DBH);
- Number of visible hollows per tree;
- Size of hollows;
- Evidence of fauna occupation;
- Proximity to creekline; and
- Suitability for threatened species to use as nesting habitat.

This information was then incorporated into the scoring system established by Gibbons and Lindenmayer (2002) to assist in identifying trees with the highest conservation significance across the Subject Site.

HBT's were located during field surveys using a non - differential hand held GPS unit. Accuracy during the field surveys was generally between +/- 3 to 5m and up to 8m.

Data Analysis

Location and tree data was downloaded into an excel spreadsheet and was subsequently analysed using an adapted method of the Gibbons and Lindenmayer

(2002) HBT scoring system. The scoring system serves to rank the HBT between 0 and 18 (0 being of lowest conservation significance and 18 being of highest conservation significance). Scores are formulated based on the criteria of Table 1. The full inventory of HBT's of the current survey and their numerical ranking is provided in Appendix 1.

Table 1: Hollow-bearing assessment criteria and scoring

HBT Assessment Criteria	Score
Diameter at Breast Height (DBH)	80-100cm = 3; 60-80cm = 1.5; <60cm = 0
Status	Living Tree = 3; Dead Tree = 1
Number of visible hollows	>5 = 3; 2-4 = 1.5; 0-1 = 0
Visible Hollow(s) Score	1 or more > 100mm = 3; 1 or more >50mm = 2; 1 or more < 50mm = 1
Proximity to waterbody	< 50 meters = 3; > 50 meters = 0
Potential for fauna occupancy	Suitable for threatened species occupancy = 3; suitable for other fauna occupancy = 2; unsuitable for fauna occupancy = 0 (see Appendix 2 for suitable hollow sizes for threatened species)

Note: This scoring system was used as a tool to identify the more important trees of the Subject Site and does not intend on diminishing the underlying importance of HBTs in the Australian landscape.

After each HBT was allocated a score, it was then classed into one of three conservation significance categories (low scores being between 0-6; medium scores 6.5-11; and high scores 11.5-18). HBT's with their conservation categories are mapped in Figure 2 using ESRI ArcMap version 10. A geo-referenced 1:25,000 topographic map has been used as the base map for this project.

In view of the accuracy of the GPS, the HBT's recorded in the current surveys include those that occur in the Subject Site and 5m buffer. Data presented in the Results have been extracted from the GIS.

Results

Number, Type and Size of Potential HBT

Over the 3 days of field survey, a total of 412 HBTs were recorded containing 1106 hollows. Thirty one of these trees are beyond the boundary of the Study Area and not considered in the analysis but are shown in Figures 2 and 3. Accordingly the total number of HBT's in the Study Area for this assessment is

381. An inventory of all HBTs recorded during the field investigation including tree data and conservation ranking has been included in Appendix 1.

Hollows were recorded in six main tree species including *Eucalyptus punctata* Grey Gum, *Eucalyptus sclerophylla* Hard-leaved Scribbly Gum, *Corymbia maculata* Spotted Gum, *Syncarpia glomulifera* subsp. *glomulifera* Turpentine, *Eucalyptus sieberi* Silvertop Ash and *Corymbia gummifera* Red Bloodwood These HBTs were distributed across the majority of habitat types in the Study Area.

Distribution of HBTs

HBTs were generally restricted to the Woodland and Open Forest habitats of the Study Area with the two main clusters in the western and central areas (Figures 2 and 3). Table 2 below summarises the data of Appendix 1 to highlight HBT's of the current surveys to be included in the two proposed zonings.

From Table 2 the medium ranked HBT's have the highest abundance within the Study Area, followed by the high then low categories. Over half of medium ranked HBT's occur in the proposed environmental zoning area.

More than half (64%) of all HBTs in the Study Area were recorded in the proposed environmental zone and 5m buffer (Figure 3). Of these 16.3% have been ranked as having high conservation significance, which is over four times as many high ranked HBTs as occurs in the residential zones (3.7%).

Discussion

In general, hollows occurring in large, remnant Hard-leaved Scribbly Gum and Grey Gum located near waterways scored the highest and are therefore are of highest conservation significance. Due to little past clearance in these areas, many of the HBTs contain large branch and truck hollows. Trees containing larger hollows suitable for forest owls and large arboreal mammals were located in remnant vegetation along creeklines and in the north-west arm of the Subject Site.

These areas of higher conservation significance fall within the proposed environmental zoning.

HBTs located in the regenerating or younger Scribbly Gum Woodland contain many small pipe and spout hollows due to the branch-shedding nature of Hard-leaved Scribbly Gum. These HBTs are generally of lower conservation significance and are located in the proposed residential zones.




