

# **Planning Proposal**

Cootamundra LEP 2013 Amendment No 4 Land Use Table Zone RU1 Primary Production



## Introduction

This planning proposal has been prepared by Cootamundra Shire Council in accordance with Section 55 of the *Environmental Planning and Assessment Act, 1979* and the relevant Department of Planning and Environment Guidelines "A *Guide to Preparing Planning Proposals*" and "A Guide to Preparing Local Environmental Plans" published by the NSW Department of Planning and Infrastructure (now Department of Planning and Environment).

# Subject Land

The planning proposal applies to all land in the Cootamundra Shire within the RU1 Primary Production land use zone in the *Cootamundra Local Environmental Plan 2013*.

# Part 1 Objectives or Intended Outcomes

The objective of the planning proposal is to amend the *Cootamundra Local Environmental Plan 2013* to enable "livestock processing industries" to be permitted with consent in Zone RU1 Primary Production.

## Part 2 Explanation of Provisions

#### 2.1 Cootamundra LEP 2013 Text

The planning proposal is seeking to amend the land use table for Zone RU1 Primary Production by removing "livestock processing industries" from Item 4 "Prohibited" and including this land use in Item 3 "Permitted with consent".

#### 2.2 Cootamundra LEP 2013 Maps

The planning proposal does not require any amendments being made to the Cootamundra LEP 2013 maps.

## **Part 3 Justification**

## Section A - Need for the Planning Proposal

#### 1. Is the planning proposal the result of any strategic study or report?

The planning proposal is not the result of any strategic study or report. Since the commencement the *Cootamundra Local Environmental Plan 2013* it has been noted that "livestock processing industries" are prohibited in the RU1 Primary Production zone. Council considers that this is an oversight in the land use table as the RU1 zone is the most appropriate and practical zone where this type of development can be located as livestock processing industries inherently require separation from residential development.

In addition, with the exception of "sawmill or log processing industries", "livestock processing industries" are the only type of rural industry that is prohibited in the RU1 Primary Production zone.

#### 2. <u>Is the planning proposal the best means of achieving the objectives or intended</u> <u>outcomes, or is there a better way?</u>

The planning proposal is the only means of achieving the objective and intended outcome.

# Section B – Relationship to Strategic Planning Framework

#### 1. <u>Is the planning proposal consistent with the objectives and actions contained within</u> <u>the applicable regional or sub-regional strategy?</u>

There are currently no regional or sub-regional strategies applicable to the Cootamundra Shire.

# 2. <u>Is the planning proposal consistent with the Council's local strategy or other local strategic plan?</u>

Council has no local strategy or other local strategic plan that is relevant to the planning proposal.Council considers that *"Livestock processing industries"* are consistent with the objectives of the RU1 Primary Production zone, and, in particular, the following objectives:

- To encourage diversity in primary industry enterprises and systems appropriate for the area, and
- To minimise conflict between land uses within this zone and land uses within adjoining zones.

#### 3. <u>Is the planning proposal consistent with applicable State Environmental</u> <u>Planning Policies?</u>

The planning proposal is consistent with all applicable State Environmental Planning Policies as detailed in Appendix 1.

# 4. <u>Is the planning proposal consistent with applicable Ministerial Directions (s.117 directions)?</u>

The planning proposal is consistent with all applicable Ministerial Directions (Section 117 Directions) as detailed in Appendix 2.

# Section C – Environmental, Social and Economic Impact

#### 1. <u>Is there any likelihood that critical habitat or threatened species, populations or</u> <u>ecological communities, or their habitats, will be adversely affected as a result of the</u> <u>proposal?</u>

As the planning proposal relates only to a change to the land use table and not to a specific development proposal or rezoning of a particular parcel of land, critical habitat or threatened species, populations or ecological communities or their habitats, will not be subject to any additional adverse impacts as a result of the planning proposal proceeding.

#### 2. <u>Are there any other likely environmental effects as a result of the planning</u> proposal and how are they proposed to be managed?

It is considered that no adverse environmental impacts are likely to arise as a direct result of the planning proposal as the change to the land use table does not relate to a specific development proposal or parcel of land.

# 3. <u>How has the planning proposal adequately addressed any social and economic impacts?</u>

The planning proposal will have positive social and economic effects by facilitating the potential for this type of development to be permitted in the only appropriate land use zone in the *Cootamundra Local Environmental Plan 2013*.

## Section D – State and Commonwealth Interests

#### 1. <u>Is there adequate public infrastructure for the planning proposal?</u>

The planning proposal will not result in any additional demand for public infrastructure.

# 2. <u>What are the views of State and Commonwealth public authorities consulted in accordance with the Gateway Determination?</u>

At this stage a Gateway Determination has not been issued. Council will consult with relevant State and Commonwealth authorities if required by the Gateway Determination.

The planning proposal will not have a direct impact on any specific State or Commonwealth interests.

*The Cootamundra Local Environmental Plan 2013* maps will not be affected by the planning proposal as the proposed amendment relates solely to the written text of the LEP.
