This should be accounted for in the generation rates adopted for the current proposal.▪ The objections under s62 were removed (22 March 2007) once a revised Traffic Support had been submitted to Council by the applicant and subsequently the RTA which resolved the above issues.▪ The RTA further advised that public transport and accessibility and improvements to the existing road network would need to be resolved. Requirements to resolve these issues have been incorporated within the associated Chapter of DCP 2005 for this site (Chapter 110 – Centre Support Development, Bateau Bay).

Dear Sir,

The RTA is in receipt of Council's correspondence dated 9th June 2006 regarding the abovementioned development application.

Please note that the RTA has no current proposals affecting or requiring any part of the property.

We understand that the current development proposal is for the rezoning of land to permit¹ the construction of a library / customer service centre and bulky goods retailing.

The RTA's primary interests are in the road network, traffic and broader transport issues, particularly the efficiency and safety of the classified road network, the security of property assets and the integration of land use and transport. With regard to the proposed rezoning, the RTA's main concerns are with the traffic generating impacts on The Entrance Road and its intersections.

The RTA has reviewed the information provided and has no objections to the rezoning proposal for the *Draft Local Environmental Plan* being exhibited. However, the RTA will maintain an objection to the proposal under section 62 of the *Environmental Planning and Assessment Act, 1979* until the following issues are addressed by Council, prior to the adoption of the LEP amendment, to the satisfaction of the RTA:

- Section 3.2 of the traffic study does not detail the size of the proposed library / customer service centre or its traffic generation. The generation from this component must be included in the overall traffic assessment.
- In some cases the background traffic volumes used in this report are lower than the volumes used by Masson Wilson Twiney in their analysis of DA 1737/03, Bay Village Shopping Centre expansion.
- The Masson Wilson Twiney report for DA 1737/03 revealed that the traffic generation rate for Bay Village Shopping Centre was almost double the rate used in the RTA guide for shopping centres. This should be accounted for in the generation rates adopted for this proposal.
