## Requesting Gateway Determination for a Planning Proposal intending amendments to Kiama LEP 2011 to permit certain types of tourist & visitor accommodation in non-urban areas

Enclosed is a Planning Proposal document prepared by Kiama Municipal Council initial Gateway determination.

## Committee recommendation that Council:

- Endorse this Planning Proposal to amend the Kiama LEP 2011 in order to:

   (a) permit Bed & Breakfasts with consent in the RU1, RU2 & E3 zones;
   (b) permit Fee Tourist Feelities with consent in the RU1, RU2 & F3 zones;
  - (b) permit Eco Tourist Facilities with consent in the RU2 & E3 zones; and
- 2. Proceed to the Department of Planning and Environment for a Gateway determination.
- 3. Request plan making delegations for this proposal as a part of the Gateway determination.
- 4. On receipt of the Gateway Determination, proceed with recommendations including requesting any further studies and public exhibition.
- Concurrently prepare an amendment to Chapter 13 Bed and Breakfast/Farm Stay of the Kiama Development Control Plan 2012 to include development controls for Eco Tourist Facilities. Report the draft amendment to Council for endorsement to proceed with community consultation.
