## 5.5 Draft Queanbeyan Local Environmental Plan (North Tralee) (Ref: C1428578; Author: Carswell/Jansen)

#### <u>Summary</u>

The purpose of this report is to provide an update with regard to the proposed rezoning of land at North Tralee and outline the next steps in regard to the process.

#### **Recommendation**

- 1. That Council progress the Draft Local Environmental Plan (North Tralee) as shown on Figure 1 and undertake all necessary actions, including preparing a Planning Proposal and associated actions if required, for the rezoning of the land for employment lands and other associated uses.
- 2. That Council agrees to the flood prone land located within the 1 in 100 ARI flood area being deferred.
- 3. That Council does not support deferral of the land identified in Figure 1 as buffer zone/open space from the Draft Queanbeyan Local Environmental Plan (North Tralee).

### Background

North Tralee has been identified as an area with the potential for rezoning for a number of years under the *Queanbeyan Residential and Economic Strategy 2031*. However due to it being within the ANEF 20-25 the land is not suitable for residential development. The land however is generally suitable to be rezoned for employment lands. A Local Environmental Study (LES) was carried out in 2005, with an updated draft LES for Council being finalised in December 2011.

The rezoning has not progressed due to the fact that the site is affected by flooding. In the past a number of options were considered with regard to the floodprone land including filling of the flood plain. This option was not acceptable from an environmental point of view and the relevant Government Departments were not supportive of such an option.

The developers have now requested that the rezoning of the North Tralee employment land be progressed based on:

- 1. The flood prone land being deferred.
- 2. The buffer zone as identified in the LES being deferred.

The purpose of deferring the flood prone land is to allow for further investigations at a later stage. This may include a preparation of a flood plain risk management study and plan to meet with the relevant requirements under the Minister's Section 117 direction.

The draft LES also identified a substantial buffer based on environmental noise studies (refer to Figure 1). This buffer was identified to protect the amenity of the urban areas of Jerrrabomberra. The purpose of deferring the buffer area would allow the developers to investigate if alternative solutions can be considered which would allow for a reduction in the buffer area (refer to Figure 2).

However the draft LES has considered this option and rejected it, even with the use of such things as using business parks as a buffer and/or various acoustical treatments.

An adequate noise buffer is required to protect the amenity of residential areas in close proximity to the site. The noise report prepared as part of the draft LES states that it is difficult to support a scenario where the employment land uses are located further to the east of the site (e.g. where the buffer is reduced). If the buffer area is deferred this will create uncertainty with regard to the future rezoning and development of this land. Noise impacts from future development of the site is raised as an issue in the draft LES and consideration of how this will be addressed needs to be included as part of the rezoning of the site and a future development control plan rather than in a piece meal fashion. Deferral of the buffer zone should therefore not be supported.

### **Process**

NSW Planning and Infrastructure have advised that Draft Queanbeyan Local Environmental Plan (North Tralee) may need to proceed under the current part of the *Environmental Planning and Assessment Act 1979* rather than under the previous part where it currently is.

This would require a Planning Proposal to be prepared, a Gateway determination to be issued by the Division and the previous work to be credited.

### **Consultation**

Consultation with Government Agencies was initially undertaken as part of the Section 62 consultation for Poplars, North Tralee and South Tralee. Community Consultation will be carried out as part of the process to finalise this draft Local Environmental Plan.

## **Compliance or Policy Implications**

The draft Local Environmental Plan will be prepared in accordance with the *Environmental Planning and Assessment Act 1979.*
