PURPOSE

The purpose of this report is to seek a Council resolution to proceed to a Gateway Determination to amend WLEP 2010 to add maps associated with Flood Studies adopted by Council.

RECOMMENDATION

<u>THAT</u> a Planning Proposal be prepared and submitted to the Department of Planning and Environment for a Gateway Determination to amend the Flood Planning Area map layer to include adopted flood maps for Gibbergunyah Creek, Nattai River, Braemar, Wembley Avenue and Farnborough Drive Moss Vale, and Robertson.

REPORT

BACKGROUND

A number of Flood Studies have been completed and adopted by Council over the past 13 months. These adopted studies and their associated mapping may now be included on the Flood Planning Area map layer of Wingecarribee Local Environmental Plan (WLEP) 2010.

REPORT

The Braemar Flood Study Stage 1 was adopted by Council at its Ordinary Meeting on 12 October 2016 and the Nattai River Floodplain Management Study & Plan (FRMSP) was adopted by Council at its Ordinary Meeting on 26 April 2017.

This report seeks a resolution to now proceed with a Planning Proposal to include the mapped data from these studies on the Flood Planning Area map layer of WLEP 2010.

It is noted that, since these two studies were adopted, any report to Council seeking adoption of a flood study now also contains a recommendation to include the study in WLEP 2010. Therefore the following studies already have a resolution to include them in WLEP 2010 as indicated below:
