Hi Graham,

Yes – I uploaded the following reports and they should be uploaded/replaced on the LEP Tracker:

- Integrated Assessment Report (updated to replace the current report)
- Aboriginal Cultural Heritage Report (updated to replace the current report)
- Aboriginal Archaeological Report (additional report)

The reports are updated and prepared in accordance with the following comments/feedback received from OEH and NSW Health:

1. **OEH** - *The archeological assessment for this rezoning remains incomplete as the three potential archeological deposits that were identified have not been excavated to establish their nature, extent and significance.*
2. **OEH** - *Lots 7-17 contain a significant amount of identified flood prone land. OEH requests that an alternative Lot arrangement be considered to avoid these potential hazards.*

As such, all issues raised by the agencies are resolved, however, the proponent is revising the PP to incorporate OEH's comment. We are hoping to receive updated PP this week. Once the revised PP is received, Council will start the public exhibition.

Furthermore, the deadline for GD is approaching i.e. 30 November 2019, I will send you a request to extend the GD by tomorrow.
