SUMMARY

 The Council's endorsement is sought to zone a recently closed laneway between Gordon Street and Peronne Avenue, Clontarf to Residential.

 The Council has previously agreed to the lane's closure and disposal to adjoining landowners at its meeting of 9 October 2000.

REPORT

At its meeting on 9 October 2000, the Council resolved to approve the road closure and sale of the laneway adjoining Nos. 18 and 20 Peronne Avenue and Nos. 21 and 23 Gordon Street Clontarf, following application to the Council by the property owners. The approval was subject to rights of carriageway over the existing driveways shared by Nos. 21 and 23 Gordon Street.

The Council has subsequently been granted title to the former laneway (**Attachment 1**) and has subdivided it into 4 allotments (**Attachment 2**) pending their disposal and consolidation with adjoining allotments.

As the land is presently unzoned an LEP amendment is required to zone the land residential, which is consistent with the zoning of adjoining lands. If the land was to remain unzoned, it could lead to inconsistencies when assessing future development/building applications, as technically the land is not be subject to planning controls.

RECOMMENDATION

That pursuant to Sections 54 and 64 of the Environmental Planning and Assessment Act 1979, the Council resolve to prepare a Draft Local Environment Plan to zone the former laneway identified as Lot 1 in DP1052463 as Zone No. 2 – Residential.
