In response to Council's Delivery Plan 2014-2017, strategy 5.1 Heritage, which states "Investigate the significance of properties in Bungonia", a report was commissioned to undertake an investigation into a potential Heritage Conservation Area in Bungonia.

At its meeting on 21 June 2016 Council resolved that (extract only):

- 1. The staff report on the proposed Bungonia Heritage Conservation Area (HCA) be received.
- In accordance with Section 55 of the Environmental Planning and Assessment Act, 1979 Council resolve to prepare a Planning Proposal to include the proposed Bungonia Heritage Conservation Area as per Council's Heritage Adviser's report titled "Bungonia – Investigation into a potential Heritage Conservation Area" plus the Parsonage and Cemetery in Part 2 of Schedule 5 of Goulburn Mulwaree LEP 2009.
- 3. Once prepared, the planning proposal be submitted to the NSW Minister for Planning and Environment for a Gateway Determination.

In accordance with Section 56 of the *Environmental Planning and Assessment Act 1979*, Council submits the enclosed planning proposal for a Gateway determination. In accordance with Section 117(2) of the *Environmental Planning and Assessment Act 1979*, Direction 5.2, Council has commenced consultation with Water NSW and a copy of their email received by Council on 6 December 2016, is enclosed.

Council believes that this matter can be appropriately determined under Section 59 of the *Environmental Planning and Assessment Act 1979*. A 28 day exhibition period is considered appropriate. It is estimated that the LEP amendment could be finalised within approximately 6 months (commencing the week following the date of a gateway determination).
