# **Alteration of Gateway Determination**

### Planning proposal (Department Ref: PP\_2015\_WYONG\_003\_00

I, the Director Regions, Hunter and Central Coast at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 10 February 2015 (as since altered) for the proposed amendment to the Wyong Local Environmental Plan 2013 as follows:

1. Change the description of the Planning Proposal:

<u>from</u> "to rezone land at 145 Johns Road, Wadalba for residential and conservation purposes"

**to** "to rezone land at 137 Johns Road, Wadalba for residential and conservation purposes"

#### 2. Delete:

condition 8 "The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination."

and replace with:

a new condition 8 "The timeframe for completing the LEP is by 17 July 2017."
