I refer to Council's letter of 23 September 2011 seeking an extension of six months time for the completion of the Planning Proposals in relation to various amendments to Wollongong LEP (West Dapto) 2010 (PP_2011_WOLLG_001_00) and for an extension of five months in relation to the widening of Iredell Road, Horsley (PP_2010_WOLLG_003_00).

I note that Council has consulted with State Agencies and has exhibited the draft Planning Proposals, but has requested additional time to complete the proposals due to the need to report the matters to the recently elected Council.

I am prepared to grant the extensions as requested. Therefore, the deadline for the completion of the planning proposal various amendments to Wollongong LEP (West Dapto) 2010 (PP_2011_WOLLG_001_00) is extended from 11 November 2011 to 11 May 2012. The deadline for the completion of the Iredell Road Planning Proposal is extended from 11 December 2011 to 11 May 2012. Please see the attached Amending Gateway Determinations.

The State Government is committed to reducing the time taken to complete planning proposals. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the new timeframe is not met.

Amending Gateway Determination

Planning Proposal (Department Ref: PP_2010_WOLLG_003_00): to add 4 properties to the Land Reservation Acquisition Map for the purpose of road widening at Iredell Road, Horsley.

I, the Deputy Director General, Plan Making & Urban Renewal as delegate of the Minister for Planning and Infrastructure, have determined under section 56(7) of the EP&A Act to alter the original Gateway Determination for the proposed amendment to the Wollongong Local Environmental Plan (West Dapto) 2010 to add properties to the Land Reservation Acquisition Map for the purpose of road widening rezone *at Iredell Road, Horsley* as follows:

Delete

"5. The timeframe for completing the LEP is to be 9 months from the week following the date of the Gateway Determination";

and replace with

"4. The timeframe for completing the LEP is to be 14 months from the week following the date of the original Gateway Determination."
