Comments in relation to Principal LEP :	Hurstville LEP 2012 was notified on 7 December 2012.
	This planning proposal is an amendment to LEP 2012 and aims to make amendments by deleting 2 local heritage items and including 32 new items in the Hurstville LEP 2012 by amending Schedule 5 and the relevant Heritage Maps.
Assessment Criteria	
Need for planning proposal :	The Department supported a heritage review to be undertaken by Council within 12 months of the gazettal of the Hurstville Comprehensive LEP 2012 and incorporate it as an amendment to Hurstville LEP 2012.
	This planning proposal is a result of the Hurstville Community Based Heritage Report (HCBHR), prepared following a heritage review.
	Council invited the community to nominate new heritage items, new areas for consideration or provide information on old heritage items.
	All nominations were assessed in accordance with the criteria contained within the NSW Heritage publication "Assessing Heritage Significance". Council used its Heritage Study Working Group (HSWG) as a result of the previous two steps, to conduct the review.
	The review identified anomalies and required new items to be included. A planning proposal is necessary to implement all these changes.

Consistency with strategic planning framework :	The planning proposal is consistent with the objectives and actions of the draft South Subregional Strategy, the Metropolitan Plan for Sydney 2036 and the Draft Metropolitan Strategy for Sydney 2031.
	Hurstville Council has advised that the planning proposal is consistent with section 5: The Four pillars of the Hurstville Community Strategic Plan 2021 (the CSP). Section 5.3 of the CSP relates to the Environmental Sustainability pillar and identifies preserving scenic and cultural heritage sites.
Environmental social economic impacts :	Council has advised that the planning proposal will likely have no effect on threatened species, populations or ecological communities or their habitats.
ž	There is unlikely to be any environmental effects as a result of the planning proposal.
	Council has advised that the social benefits related to preservation and strengthening of cultural heritage in the Hurstville LGA are the main reasons for preparing this planning proposal.
	Council has advised that social and economic impacts will be minimal. Any proposal to develop, redevelop or demolish any heritage item will need to be considered against clause 5.10 (Heritage Conservation) of the Hurstville LEP 2012. This does not prohibit development.
