EXECUTIVE SUMMARY

The purpose of this report is to advise Council on the initial consultation with the residents on the potential individual heritage items nominated as part of the review and update of *Hurstville Heritage Study 1988*.

The Heritage Review report initially identified 57 new individual items (in addition to the proposed North Beverly Hills and Kemps Estate Conservation Areas).

Submissions received have been considered by the Heritage Study Working Group (HSWG). The HSWG recommends that 9 of the items be removed from the list and that the remaining items proceed to be included as heritage items in Hurstville Local Environmental Plan 2012 (this excludes the consideration of the two proposed conservation areas which are subject to separate reports in this business paper).

This report also lists the recommendations of the Heritage Review as endorsed by the HSWG in relation to items to be removed from LEP 2012 and other recommendations relating to the general management of heritage in the Hurstville LGA.

This recommendation is now forwarded to Council for its consideration.

THAT Council receive the report submitted by the Heritage Study Working Group.

REPORT DETAIL

BACKGROUND Draft Hurstville Heritage Study Review

The Department of Planning and Infrastructure (the DP&I) required Council to complete a comprehensive review (the Review) of the heritage in Hurstville within 12 months of the gazettal of Hurstville (Comprehensive) LEP 2012 and incorporate it as an amendment to Hurstville LEP 2012. Also, the *Hurstville Heritage Study 1988*, upon which the current heritage listings are based, is nearly 25 years old and is in need of a major review. The Hurstville LEP 1994 listed approximately 140 local heritage items. The Hurstville LEP 2012 includes all heritage items in Hurstville LEP 1994 with the exception of 9 items which have been approved for demolition.

The Review is jointly funded by Hurstville City Council and the Office of Environment & Heritage under the *NSW Heritage Grants Program 2011-2013 Caring for our heritage.* The Review is being progressed in accordance with the Steps 1-20 in the *Community-based Heritage Studies: A Guide* (the Heritage Guidelines) issued by the Office of Environment & Heritage.

OVERVIEW OF DRAFT REPORT ON HURSTVILLE COMMUNITY BASED HERITAGE STUDY REVIEW

A draft report on Hurstville Community based Heritage Study Review and updated heritage listings were prepared by the Heritage Consultant in October 2012. The report comprises of two parts:

- i. A written report that provides the methodology and scope of the Study, revised historical summary and themes and recommendations.
- ii. Inventory Sheets that provide relevant data on the existing and the proposed items -Initially, a total of 57 potential items and two heritage conservations areas were proposed by the HSWG.

Report recommendation in relation to the proposed items

The Report recommends Council to prepare a Planning Proposal and an amendment to the Hurstville Local Environmental Plan 2012 in accordance with the heritage provisions of the Department of Planning and Infrastructure's Standard Instrument incorporating 48 new sites as heritage items in accordance with the recommendations of this Study Review.

Process for heritage listing

In accordance with Heritage Council guidelines the process for listing an item or area requires consideration of heritage significance in line with a range of criteria listed below:

NSW Heritage Assessment Criteria used to assess a proposed item / area

Criterion (a)

An item is important in the course, or pattern, of NSW's cultural or natural history (or the cultural or natural history of the local area); **Criterion (b)**

An item has strong or special association with the life or works of a person, or group of persons, of importance in NSW's cultural or natural history (or the cultural or natural history of the local area);

Criterion (c)

An item is important in demonstrating aesthetic characteristics and/or a high degree of creative or technical achievement in NSW (or the local area);

Criterion (d)

An item has strong or special association with a particular community or cultural group in NSW (or the local area) for social, cultural or spiritual reasons;

Criterion (e)

An item has potential to yield information that will contribute to an understanding of NSW's cultural or natural history (or the cultural or natural history of the local area);

Criterion (f)

An item possesses uncommon, rare or endangered aspects of NSW's cultural or natural history (or the cultural or natural history of the local area);

Criterion (g)

An item is important in demonstrating the principal characteristics of a class of NSW's

- cultural or natural places; or
- cultural or natural environments.
- (or a class of the local area's cultural or natural places; or
- cultural or natural environments.)

Where an item or area meets these criteria it may be considered for listing under a local environmental plan as a heritage item or conservation area. Such listing then affords the item or area protection under State heritage legislation by placing which additional requirements on any decisions regarding alterations, development or demolition.

Identification of Proposed Items

A total of 13 potential item nominations were received during the designated nomination period from both community members and the Heritage Study Working Group members. Further surveys have been undertaken to identify additional potential heritage items within the Hurstville LGA as well as review of items listed on the Heritage and Conservation Registers of RailCorp and the Sydney Water Corporation; and items identified by the National Trust of Australia (NSW) and the Australian Institute of Architects. A total of 57 individual potential heritage items were originally recommended for listing under the HLEP 2012.

The Inventory Sheets for each item are attached in the Appendix to this report.

CONSULTATION PROCESS

In accordance with the Heritage Guidelines, there are two stages for the community to comment – an early consultation stage with only the affected owners and a State endorsed public consultation stage. The subject consultation is part of the early consultation stage. A further round of public consultation for any items that Council resolved to include as heritage items will be undertaken as part of the Draft Local Environmental Plan process.

The early consultation period extended from **mid-November 2012 to 11 January 2013** and has involved the following:

Councillor Briefing

Councillors briefing on potential heritage items and areas was held as part of the Councillor Strategic Planning Workshop from 9 -11 November 2012.

Heritage Study Working Group

Established in December 2011, this included representatives from the local community, National Trust of Australia (NSW), Oatley Heritage Group, Aboriginal community groups and Council staff. The HSWG has met on six (6) occasions to date.

Communications

A dedicated page was established with relevant information available on Council's website (under <u>http://www.hurstville.nsw.gov.au/Hurstville-Heritage-Study-1988.html</u>)

Letters

A letter was sent to the owners of each individual item and invited submissions. The letter advising of the ongoing Hurstville Heritage Study Review was accompanied by:

- a Heritage Inventory Sheet for each property explaining its heritage significance; and
- a Heritage Branch publication, namely, *Heritage Listing Explained What it means for you*.

Individual Meetings With Property Owners

Owners of proposed heritage items were invited to attend meetings at Council (with Council's heritage consultant) to discuss the proposed listing of their items.

A total of 17 meetings were held to discuss 30 the individual items, including a meeting with Council staff to discuss Council owned items.

SUBMISSIONS & RECOMMENDATIONS OF THE HSWG

Council received written submissions for 29 of the proposed heritage items. As previously mentioned, Council staff and the heritage consultant also meet with 17 land owners regarding the potential items.

Following community consultation submissions were reviewed and further investigation on some items was undertaken. Of the original 57 potential item recommendations 9 individual items have been removed from consideration for listing under the HELP 2012. The remainder of the potential items (48 items) have been recommended by the HSWG for listing in the HLEP 2012.

A summary of the submissions and the recommendations of the HSWG for all the heritage items are located in Appendix 1 of this report.

EXISTING HERITAGE ITEMS TO BE REMOVED FROM LEP 2012 AND DRAFT HURSTVILLE CITY CENTRE LEP 2012

The Report on the Heritage Study recommends the removal of the following items from Schedule 5 of the Hurstville LEP 2012 and the Draft City Centre LEP. These items are recommended to be removed from the LEPs as they have either been demolished or have been irreversibly altered.

- 112 Forest Road, Hurstville
- Mashman Avenue, Kingsgrove Mashman Pottery and Tile Works
- 136 Forest Road, Hurstville
- 316 Forest Road, Hurstville

OTHER RECOMMENDATIONS ARISING FROM THE HERITAGE STUDY REVIEW

The Report also makes the following general recommendations in relation to the management and assessment of heritage in the Hurstville LGA

"Recommendation 4: Provide guidelines on house types in the local area with restoration and adaptation advice. Such information could be delivered both through an on-line format and through Heritage Information Brochures.

Recommendation 5: Ensure that assessment of development applications takes into account the impact of the proposed development on the heritage significance of the heritage items within the area.

Recommendation 6: That Council investigate alternative means of providing financial assistance to owners of heritage items, for example establishing a local heritage fund, with funding assistance from the Local Government Heritage Management Program.

Recommendation 7: That Council consider the commissioning of an assessment of the Aboriginal Cultural Heritage in the Hurstville LGA.

Recommendation 8: That Council make the Heritage Study Review available for public viewing as part of public exhibition of the Planning Proposal and LEP amendment and following finalisation. Hard copies should be kept at Council, an electronic copy available on Council's website, the online catalogue of the Hurstville City Library and the website of NSW Office of Environment and Heritage.

Recommendation 9: That Council investigate whether to establish a Heritage Advisory Committee and engage regular services of a heritage advisor as required.

Recommendation 10: That Council establishes a program for preparation of conservation documents for Council owned heritage properties. Concise conservation management plans or strategies for Council owned properties can be used as an example for private owners of heritage items.

Recommendation 11: That Council encourages local historical societies and individuals to prepare area histories, oral histories if required and establish liaison with other historical societies and groups in the LGA.

Recommendation 12: That Council review the adequacy of storage for the Library, Museum and Gallery section, including the Local Studies collection.

Recommendation 13: That Council investigate whether to establish a conservation and heritage award to acknowledge the works and efforts of the community, society or heritage item owners, which may encourage other heritage item owners to appreciate the values of their properties and undertake conservation works to preserve the heritage item stock in the local area.

Recommendation 14: That Council considers the ranking map of discontinued Kemps Estate Conservation Area nomination when assessing any future development within the area. Those properties that had been ranked as Contributory A and Contributory B should be archivally recorded for future reference and for the documentation of the development history of Mortdale.

Recommendation 15: That Council ensure the street trees that had been nominated for listing and excluded due to the infrastructure issues be managed under Plans of Management. Assessment by suitably qualified arborist should be made prior to removal of any trees considered under the potential listing" (See Heritage Study Review Report).

NEXT STEPS

Based on the recommendations from the HSWG and submissions, this report is referred to Council for its consideration. In this regard the options are:

- 1. to adopt the recommendations of the HSWG;
- 2. to modify the recommendation of the HSWG; or
- 3. to resolve not to proceed with the recommendation of the HSWG.

If Council resolves to adopt all or some of the items as heritage items, the next step is include the preparation of a Planning Proposal incorporating the proposed items into the Hurstville LEP 2012. This will be forwarded to the Department of Planning &Infrastructure for issuing of a Gateway Determination allowing Council to publicly exhibit the Planning Proposal.
