Planning proposal to amend draft Leichhardt Local Environmental Plan 2013

I refer to Council's letter requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act, 1979 (EP&A Act) in respect of the planning proposal to rezone 141 and 159 Allen Street, Leichhardt from IN2 Light Industrial to R1 Residential.

As delegate of the Minister for Planning and Infrastructure, I have determined the planning proposal should proceed subject to the conditions in the attached gateway determination.

I have also agreed the planning proposal's inconsistency with S117 Direction 1.1 Business and Industrial Zones is of minor significance. The planning proposal is considered consistent with all the other relevant S117 Directions. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 9 months of the week following the date of the gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2013_LEICH_004_00): to rezone 141 and 159 Allen Street, Leichhardt from Light Industrial to Residential

I, the Acting Deputy Director General, Planning Operations and Regional Delivery, at the Department of Planning and Infrastructure, as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the *Environmental Planning and Assessment Act*, 1979 (EP&A Act) that an amendment to the draft Leichhardt Local Environmental Plan 2013 (LEP 2013) to rezone 141 and 159 Allen Street, Leichhardt should proceed subject to the following conditions:

- 1. Community consultation is required under sections 56(2)(c) and 57 of the EP&A Act as follows:
 - (a) the planning proposal is classified as low impact as described in the Department's *A Guide to Preparing LEPs 2013* and must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of the Department's *A Guide to Preparing LEPs 2013*.
- 2. Council is to demonstrate that the planning proposal satisfies the requirements of State Environmental Planning Policy (SEPP) 55 Remediation of Land. Any required site contamination investigation report is to be included as part of the public exhibition material.
- 3. Council is to prepare the necessary maps in accordance with the Department's Standard Technical Requirements for LEP Maps 2012. Council is to ensure that the maps are publicly exhibited with the the planning proposal in accordance with the exhibition requirements above.
- 4. Council is to arrange for an urban design study that deals with contextual analysis, height, comparative floor space ratio analysis, solar access, separation between buildings, privacy impacts and deep soil landscaping. Council is to ensure that this study is publicly exhibited in accordance with the exhibition requirements below.
- 5. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act and/or to comply with the requirements of relevant S117 Directions:
 - Department of Education and Communities
 - Office of Environment and Heritage
 - Transport for NSW
 - Roads and Maritime Services
 - Sydney Water

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

- 6. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 7. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
