THAT Council:

- 1. receive and note the report;
- 2. submit the planning proposal to the Department of Planning and Infrastructure for Gateway determination;
- concurrent with the Gateway submission, engage James Mather Delaney Design Pty Ltd (the consultants undertaking Council's Public Domain Study) to peer review the proposed public space design and commission a peer review of the proposed building envelope and relationship to the character of the Marrickville town centre by two suitably qualified consultants;
- 4. further consider the planning proposal request and Voluntary Planning Agreement and findings of the peer review processes prior to any public exhibition of the planning proposal;
- 5. seek an amendment to Marrickville LEP 2011 as part of the planning proposal submission for the proposed development to require a design competition process as part of any development application for buildings of a (yet to be determined) significant scale; and
- 6. write to the Minister for Transport and Transport for NSW to inform of the planning proposal request and to seek consultation concerning the co-ordination of planning processes for the public space associated with the proposed development and the proposed upgrade of Marrickville Railway Station.
