Re: Planning Proposal to rezone land at Tumbarumba Road Batlow under Section 73A

I am writing in response to your Council's letter dated 6 August 2010 requesting a Gateway Determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend the Tumut Local Environmental Plan 1990 to rezone land at Lot 350 DP 757214 Tumbarumba Road, Batlow from 8(a) National Park to 1(b) Rural Special Agriculture under Section 73A of the Act.

As delegate of the Minister for Planning, I have now determined that the planning proposal should proceed under s73A of the Act and subject to the conditions in the attached Gateway Determination.

The Department, in consultation with Council and the Parliamentary Counsel, will now make the necessary arrangements to finalise the LEP. The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and this should be completed within three (3) months.

Gateway Determination

Planning Proposal (Department Ref: PP_2010_TUMUT_001_00): to rezone land at Lot 350 DP 757214 Tumbarumba Road, Batlow from 8(a) National Park to 1(b) Rural Special Agriculture under Section 73A.

I, the Deputy Director General, Plan Making & Urban Renewal as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the Tumut Local Environmental Plan 1990 to rezone land at Lot 350 DP 757214 Tumbarumba Road, Batlow from 8(a) National Park to 1(b) Rural Special Agriculture under Section 73A should proceed subject to the following conditions:

1. This is a minor matter that can be dealt with under Section 73A of the EP&A Act.
2. No public hearing is required to be held into the matter under section 56(2)(e) of the EP&A Act.
3. The timeframe for completing the LEP is to be **3 months** from the week following the date of the Gateway determination.
