I RECOMMEND for the approval of His Excellency the Governor, with the advice of the Executive Council, that pursuant to section 30(2) of the *Local Government Act 1993*, the insertion of certain land into Part 2 of Schedule 4 to the Bega Valley Local Environmental Plan 2013 by the Bega Valley Local Environmental Plan 2013 (Amendment No 8).

Clause 5.2(5) of the *Bega Valley Local Environmental Plan 2013* provides that the public land described in Part 2 of Schedule 4, to the extent (if any) that it is a public reserve, ceases to be a public reserve when the description of the land is inserted into that Part and is discharged from all interests affecting the land or any part of the land (unless otherwise specified).

An extract of Schedule 1, clause 3 of the Bega Valley Local Environmental Plan 2013 (Amendment No 8) identifying the land to be reclassified is/attached.

in respect of proposed Bega Valley Local Environmental Plan 2010 (Amendment No 8), under s.59(2) of the Environmental Planning and Assessment Act 1979.

EXPLANATORY NOTE

Proposed reclassification of land by Bega Valley Local Environmental Plan 2013 (Amendment No 8)

Clause 5.2(5) of *Bega Valley Local Environmental Plan 2013* is made pursuant to section 30 of the *Local Government Act 1993* which provides for the reclassification of community land as operational. This clause provides that the public land described in Part 2 of Schedule 4, to the extent (if any) that it is a public reserve, ceases to be a public reserve when the description of the land is inserted into that Part and is discharged from all interests affecting the land or any part of the land (unless otherwise specified).

The Bega Valley Local Environmental Plan 2013 (Amendment No 8) will insert Part of Lot 182 DP 1100739, Lot 299 DP 1151525 and Lot 14 DP 249924 into Part 2 of Schedule 4 to Bega Valley Local Environmental Plan 2013.

This will enable the reclassification of the land from community to operational land and to provide for new buildings, facilities and uses, and also provides Council with the opportunity to sell or lease some of the properties.

Section 30(2) of the *Local Government Act 1993* provides that a provision of a proposed LEP that reclassifies community land as operational has effect according to its tenor, but only if the Governor has, before the making of the LEP, approved of the provision. Accordingly, the Governor's approval is sought for Schedule 1, clause 3 of the *Bega Valley Local Environmental Plan 2013 (Amendment No 8)*.

Parliamentary Counsel has issued an Opinion dated 5 June 2015 that the Bega Valley Local Environmental Plan 2013 (Amendment No 8) may be legally made.
