Planning proposal to amend Gosford Local Environmental Plan (2014)

I am writing in response to your Council's letter dated 1 May 2014 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend Gosford Local Environmental Plan (2014) to permit a Resource Recovery Facility on land currently zoned SP2 Infrastructure at Doyle Street and Empire Bay Drive, Kincumber.

A planning proposal is not required to permit a resource recovery facility on this site as it is already permitted on land zoned SP2 Infrastructure under State Environmental Planning Policy (Infrastructure) 2007. However Council has indicated it seeks to amend the SP2 Sewerage System notation on the Land Zoning Map to clearly indicate its intentions to the community, and this Gateway is issued on that basis.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Council may still need to obtain the agreement of the Department's Secretary to comply with the requirements of relevant S117 Directions. Council should ensure this occurs prior to the plan being made.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending Local Environmental Plan (LEP) is to be finalised within 3 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2014_GOSFO_005_00): to amend Gosford Local Environmental Plan (2014) to include the notation 'and Resource Recovery Facility' on the Land Zoning Map currently identified as 'SP2 Sewerage System' at Doyle Street and Empire Bay Drive, Kincumber

I, the General Manager, Hunter and Central Coast Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the EP&A Act that an amendment to the Gosford Local Environmental Plan (LEP) (2014) to include the notation 'and Resource Recovery Facility' on the Land Zoning Map currently identified as 'SP2 Sewerage System' at Doyle Street and Empire Bay Drive, Kincumber should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, Council is to update the planning proposal to:
 - include a statement in the 'objectives' and 'explanation of provisions' to clarify the amendment is for a notation change to 'SP2 Sewerage System' to add 'and Resource Recovery Facility' on the Land Zoning Map.
 - include discussion to clarify the notation change is not required to permit the use for a 'resource recovery facility' as it is already permitted under SEPP (Infrastructure) 2007 and is required only to signal Council's intention with regard to the future land use on the site.
 - include discussion on the need for waste facilities in the LGA and the capacity of current and proposed future facilities to meet future demand in the Need section of the planning proposal.
 - give consideration to whether it is necessary to identify the location of the resource recovery facility on the subject lots given it is permissible in the SP2 Infrastructure zone.
 - amend the land zoning map to identify Gosford LEP 2014 in the title and include a legend and north point.
 - include a proposed zoning map with the notation 'SP2 Sewerage System and Resource Recovery Facility'.
- 2. Council is to update the planning proposal to include sufficient additional information to adequately demonstrate consistency or justify any inconsistency with the S117 Direction 4.4 Planning for Bushfire Protection once it has undertake consultation with the relevant public authority.
- 3. Council update its consideration of State Environmental Planning Policy (Infrastructure) 2007 prior to public exhibition of the planning proposal.
- 4. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **14 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing LEPs (Department of Planning and Infrastructure 2013).



- 5. Consultation is required with the NSW Rural Fire Service under section 56(2)(d) of the EP&A Act. NSW Rural Fire Service is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.
- 6. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- 7. The timeframe for completing the LEP is to be **3 months** from the week following the date of the Gateway determination.
