SUBJECT: REQUEST FOR A LEGAL OPINION TO CORRECT CERTAIN ZONING AND NOTATION ERRORS IN WINGECARRIBEE LEP 2010-PP_2011_WINGE_002_00 Amendment No 6

PURPOSE

• To request a Local Environmental Plan (LEP) be drafted to give effect to a Planning Proposal to amend Wingecarribee Local Environmental Plan 2010.

RECOMMENDATION

• That Legal Branch request a LEP for the subject Planning Proposal be drafted by Parliamentary Counsel.

BACKGROUND

- The Planning Proposal seeks to correct errors made in the colouring on the Natural Resources Sensitivity Map, amend two Land Zoning and Lot Size Map sheets; correct land description and numbering errors in Schedule 1, and on the Schedule 1 Map.
- A summary of the purpose and intent of the LEP with more information about each matter is also at Attachment 1.

ISSUE

- The Gateway Determination was to correct a number of zoning and lot size errors; amend land descriptions in Schedule 1 and numbers on Schedule 1 Map; and amend incorrect colouring on Natural Resources Map.
- The Planning Proposal is consistent with the Gateway Determination on the 2nd of May 2011
 (attached) for all sites, maps and notations.
- The Planning Proposal was exhibited from 25th May 2011 to the 8th June 2011 and copies of the Planning Proposal were sent to government agencies as required in the Gateway Determination. No public hearing was held or required for any of the matters, and the Director General considers that any inconsistencies with s117 Directions are of a minor significance.
- No public submissions were received during the exhibition period.
- Subject to consultation with Wingecarribee Shire Council regarding the final drafting of the LEP, the draft plan will be put to the Minister and/or his delegate to be made.
