1 Name of plan

This plan is Wollongong Local Environmental Plan 2009 (Amendment No).

2 Aims of plan

This plan aims:

- to reclassify twelve parcels of land to which this plan applies from Community Land to Operational Land within the meaning of the Local Government Act 1993; and
- (b) to remove all trusts and other interests from the reclassification sites; and
- (c) to rezone Part Lot 192 DP 700165, Nolan Street, Berkeley from RE1 Public Recreation to E4 Environmental Living; and
- (d) to rezone Part Lot 43 (Conveyance No 224 Book 2243) Keira Mine Road, Mount Keira from RE1 Public Recreation to R2 Low Density Residential; and
- (e) to rezone Lot 1 DP 243820, Eyre Place, Warrawong from RE1 Public Recreation to R2 Low Density Residential; and
- (f) to provide the opportunity for additional floor space, increasing the Floor Space Ratio from 0.5:1 to 0.75:1 for Part Lot 207 DP 816857, Mercury Street, Gwynneville.
