## Re: DRAFT AMENDMENT TO DUNGOG LEP 2014 RECLASSIFICATION OF LAND OF LOT 1 DP 562046 DURHAM ROAD, GRESFORD

Reference is made to previous correspondence and discussions with you regarding the draft amendment to Dungog LEP for reclassification of land at Lot 1 DP 562046 Durham Road Gresford.

Dungog Council at its meeting of the 19 August 2014 resolved:

- 1. "Council resolve to reclassify Lot 1 DP 562046 Durham Road Gresford from community land to operational land to allow sale of the property;
- 2. Council authorizes the notification of Council's resolution, and submits an amended Planning proposal pursuant to section 55 of the Environmental Planning and Assessment Act 1979 (EP&A Act 1979), to the Department of Planning & Environment;
- 3. Upon receipt of the Gateway Determination under section 56 of the EP&A Act 1979 and in accordance with any direction, Council authorizes the exhibition of the Planning Proposal;
- 4. Council authorizes notification of the public hearing in a local newspaper in accordance with section 29 of the Local Government Act 1993."

- A copy of Council's resolution of 19 August 2014 Minute No. 36508; and
