


Figure 69: Item 14 - Aerial photograph of subject land




Figure 70: Item 14 - Existing Land Zoning Map (LZN)




Figure 71: Item 14 - Proposed Land Zoning Map (LZN)




Figure 72: Item 14 - Existing Land Reservation Acquisition Map (LRA)




Figure 73: Item 14 - Proposed Land Reservation Acquisition Map (LRA)




Figure 74: Item 14 - Existing Height of Buildings Map (HOB)




Figure 75: Item 14 - Proposed Height of Buildings Map (HOB)




Figure 76: Item 14 - Existing Lot Size Maps (LSZ)




Figure 77: Item 14 - Proposed Lot Size Maps (LSZ)




Figure 78: Item 15 - Aerial photograph of subject land




Figure 79: Item 15 - Existing Land Zoning Map (LZN)




Figure 80: Item 15 - Proposed Land Zoning Map (LZN)




Figure 81: Item 15 - Existing Land Reservation Acquisition Map (LRA)




Figure 82: Item 15 - Proposed Land Reservation Acquisition Map (LRA)




Figure 83: Item 15 - Existing Height of Buildings Map (HOB)




Figure 84: Item 15 - Proposed Height of Buildings Map (HOB)




Figure 85: Item 15 - Existing Lot Size Maps (LSZ)




Figure 86: Item 15 - Proposed Lot Size Maps (LSZ)




Figure 88: Item 16 - Existing Land Zoning Map (LZN)




Figure 89: Item 16 - Existing Land Reservation Acquisition Map (LRA)




Figure 90: Item 16 - Proposed Land Reservation Acquisition Map (LRA)
