# Alteration of Gateway Determination

### Planning proposal (Department Ref: PP\_2014\_GLAKE\_006\_00)

I, General Manager, Hunter and Central Coast Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 ("*EP&A Act") to alter the Gateway determination dated 9 December 2014 for the proposed amendment to the Great Lakes Local Environmental Plan 2014 as follows:

1. Change the description of the Planning Proposal

#### from

Planning Proposal (Department Ref: PP\_2014\_GLAKE\_006\_00): to amend the R3 Medium Density Residential zone density and dwelling permissibility.

#### to

Planning Proposal (Department Ref: PP\_2014\_GLAKE\_006\_00): to amend the R3 Medium Density Residential zone density, dwelling permissibility, and minimum lot size map.

2. Delete:

"condition 1"

and replace with:

1. Prior to, or on completion of community consultation, Council is to update the planning proposal to:

(a) demonstrate how many dwellings per hectare is a feasible and achievable target for the R3 Medium Density Zone in the areas subject to the proposed minimum density provisions; and

(b) include an appropriate definition of density that will be used to measure the targets; and

(c) include proposed changes (if any) to minimum lot size, height of building, floor space ratio and any other relevant LEP provision; and
