Dear Mr Gordon,

Planning proposal to amend Wingecarribee Local Environmental Plan 2010

I am writing in response to your Council's request for a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend the minimum lot size for land at 453 Exeter Road, Sutton Forest to 4000sqm, amend the minimum lot size for the Burrawang Hotel at 14-16 Hoddle Street, Burrawang to 1ha and amend the heritage map and schedule 5 Environmental Heritage for these sites, amend the minimum lot size for land at 123 Bong Bong Street, Mittagong to 4000sqm and rezone part of the site to E3 Environmental Management.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

If practicable, Council is to identify the new (interim) Lot and DP numbers for the proposed subdivision of Lot 1 DP 198682 at Hoddle Street, Burrawang and amend the planning proposal to advise that it will also amend schedule 5 Environmental Heritage to reflect the new lot and DP numbers. Alternatively, Council can address this matter in a housekeeping amendment at a later time. The location of the heritage item should be clearly identified on a map.

I have also agreed the planning proposal's inconsistencies with S117 Directions 1.5 Rural Lands, 2.1 Environmental Protection Zones and 3.4 Integrating Land Use and Transport are of minor significance. No further approval is required in relation to these Directions.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has now accepted this delegation. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan. Council should contact the relevant regional planning team of the department should it require assistance in relation to the exercise of its delegation.

The amending LEP is to be finalised within 9 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under s54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2013_WINGE_001_00: to make various amendments to Wingecarribee Local Environmental Plan (LEP) 2010.

I, the Director General, Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Wingecarribee Local Environmental Plan (LEP) 2010 to amend the minimum lot size for land at 453 Exeter Road, Sutton Forest to 4000sqm, amend the minimum lot size for the Burrawang Hotel at 14-16 Hoddle Street, Burrawang to 1ha and amend the heritage map and schedule 5 Environmental Heritage for these sites, amend the minimum lot size for land at 123 Bong Bong Street, Mittagong to 4000sqm and rezone part of the site to E3 Environmental Management should proceed subject to the following conditions:

1. Prior to undertaking public exhibition, Council is to amend the planning proposal to include a project timeline, consistent with Section 2.6 Part 6 of the *A Guide to Preparing Planning Proposals*. The project timeline is to provide a mechanism to monitor the progress of the planning proposal.
2. Prior to undertaking public exhibition, Council is to amend the planning proposal to demonstrate the proposal's consistency or justify any inconsistency with S117 Direction 2.3 Heritage Conservation. The planning proposal is to be amended to address the impacts of reducing the minimum lot size on land containing heritage items at 453 Exeter Road, Sutton Forest and the Burrawang Hotel at 14-16 Hoddle Street, Burrawang.
3. Council is to consult with the NSW Rural Fire Services as per the requirements of S117 Direction 4.4 Planning for Bushfire Protection and amend the planning proposal, if necessary, to take into consideration any comments made prior to undertaking public exhibition.
4. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - (a) the planning proposal must be made publicly available for **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2012)*.
5. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act:
 - NSW Rural Fire Service

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material. Each public authority is to be given at least 21 days to comment on the proposal, or to indicate that they will require additional time to comment on the proposal. Public authorities may request additional information or additional matters to be addressed in the planning proposal.



6. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
7. The timeframe for completing the LEP is to be **9 months** from the week following the date of the Gateway determination.
