#### PURPOSE

The purpose of this report is to update Council on the status of a Planning Proposal to rezone and reclassify Lot 5 DP 1087928, being Eridge Park, corner Eridge Park Road and Moss Vale Road, Burradoo, to permit development for the purposes of a Residential Aged Care Facility. This development is part of a Proposal by the applicant titled the Wingecarribee Sport, Leisure & Living Proposal which also includes the establishment of sporting and leisure facilities on the property known as Wongabri, (Lot 2 DP 258454 and Lot 3 DP 609703), 586-588 and 590-592 Moss Vale Road Burradoo, and the refurbishment of the Mittagong pool and adjoining leisure centre.
