## Planning Proposals - Gateway Determination extensions

As the delegate of the Minister for Planning and Infrastructure, in accordance with section 56(7) of the Environmental Planning and Assessment Act 1979, I have amended the Gateway Determinations for each of the four planning proposals as follows:

Planning Proposal description	Current LEP completion date	Extended timeframe
PP_2011_WOLLG_004_00 to amend zone boundaries and to rezone land at Mount Ousley Road, Mount Keira.	7 February 2014	6 months (7 August 2014)
PP_2012_WOLLG_005_00 to consolidate Wollongong (West Dapto) LEP 2010 with Wollongong LEP 2009.	5 November 2013	6 months (5 May 2014)
PP_2012_WOLLG_011_00 to rezone land at Bellambi and Windang for business purposes.	17 February 2014	3 months (17 May 2014)
PP_2013_WOLLG_001_00 to rezone land at Windang for environmental living purposes.	19 January 2014	3 months (19 April 2014)
