## Planning proposal to amend Wingecarribee Local Environmental Plan 2010

I am writing in response to your Council's letter dated 26 April 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to correct a zoning error by rezoning Lot 3 DP 1076561 Merrioola, at 205 High Range Lane, High Range from E2 Environmental Conservation to RU2 Rural Landscape and applying a minimum lot size of 40ha to the subject land.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan. Council should contact the regional office of the department should it require assistance with access to GIS support.

The amending Local Environmental Plan (LEP) is to be finalised within 3 months of the week following the date of the Gateway determination. As it has been determined that this a minor amendment, Council is not required to undertake community consultation for the planning proposal and is to request Parliamentary Counsel's Office commence drafting the instrument as soon as possible. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

# **Gateway Determination**

Planning proposal (Department Ref: PP\_2013\_WINGE\_006\_00): to correct a zoning error by rezoning and applying a minimum lot size for land at High Range.

I, the Executive Director, Rural and Regional Planning at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Wingecarribee Local Environmental Plan (LEP) 2010 to correct a zoning error by rezoning Lot 3 DP 1076561 Merrioola, at 205 High Range Lane, High Range from E2 Environmental Conservation to RU2 Rural Landscape and applying a minimum lot size of 40ha to the subject land should proceed subject to the following conditions:

- No community consultation is required under sections 56(2)(c) and 57 of the 1. Environmental Planning and Assessment Act 1979 ("EP&A Act").
- No consultation is required with public authorities under section 56(2)(d) of the EP&A Act. 2.
- A public hearing is not required to be held into the matter by any person or body under 3. section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).
- The timeframe for completing the LEP is to be 3 months from the week following the date 4. of the Gateway determination.
