Planning proposal to amend Rockdale Local Environmental Plan (LEP) 2011

I am writing in response to your Council's letter dated 9 September 2013 requesting a Gateway determination under section 56 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") in respect of the planning proposal to amend Rockdale Local Environmental Plan (LEP) 2011 for land within the Rockdale Town Centre.

As delegate of the Minister for Planning and Infrastructure, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

Council may still need to obtain the Director General's agreement to satisfy the requirements of relevant S117 Directions. Council should ensure this occurs prior to the plan being made.

The Minister delegated his plan making powers to councils in October 2012. It is noted that Council has requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan.

The amending LEP is to be finalised within 12 months of the week following the date of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the department for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet these commitments, the Minister may take action under section 54(2)(d) of the EP&A Act if the time frames outlined in this determination are not met.

Gateway Determination

Planning proposal (Department Ref: PP_2013_ROCKD_001_00): to make various amendments to the Rockdale Local Environmental Plan 2011.

I, the Acting Executive Director, Metropolitan Planning at the Department of Planning and Infrastructure as delegate of the Minister for Planning and Infrastructure, have determined under section 56(2) of the EP&A Act that an amendment to the Rockdale Local Environmental Plan (LEP) 2011 to:

- amend objectives within zone B2 Local Centre;
- amend subclause 4.3(2A) to provide incentives for additional building height on certain land;
- amend the maximum building height for certain land;
- rezone certain land to B4 Mixed Use, RE1 Public Recreation and R4 High Density Residential;
- add land to the Land Reservation Acquisition Map:
- amend Street Frontages Map;
- remove FSR controls for land within the Rockdale Town Centre;
- amend FSR of certain land from 0.5:1 to 1:1; and
- amend clause 4.4 (2C) by deleting the sub clause 4.4 (2C) (a).

should proceed subject to the following conditions:

- 1. Prior to undertaking public exhibition, Council is to update the planning proposal to:
 - amend the FSR for land at No. 1 King Edward Street, Rockdale from 0.5:1 to 1:1 and clarify this amendment within the planning proposal and associated map; and
 - clarify the estimated job growth figures under Section B (Sydney South Draft Subregional Strategy) of Part 3 Justification on page 6 of the planning proposal.
- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
 - (a) the planning proposal must be made publicly available for a minimum of **28 days**; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of *A Guide to Preparing LEPs (Department of Planning & Infrastructure 2013)*.
- 3. Consultation is required with the following public authorities under section 56(2)(d) of the EP&A Act and/or to comply with the requirements of relevant S117 Directions:
 - Sydney Water
 - Transport for NSW
 - Department of Infrastructure and Regional Development (S117 Direction 3.5 Development Near Licensed Aerodromes)
 - Sydney Airport Corporation Ltd (S117 Direction 3.5 Development Near Licensed Aerodromes)

Each public authority is to be provided with a copy of the planning proposal and any relevant supporting material, and given at least 21 days to comment on the proposal.

4. A public hearing is not required to be held into the matter by any person or body under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it



may otherwise have to conduct a public hearing (for example, in response to a submission or if reclassifying land).

5. The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination.
