Additional Information:

The Regional Director, Southern Region, Planning Operations & Regional Delivery, as delegate of the Minister for Planning and Infrastructure, determine under section 56(2) of the EP&A Act that an amendment to the Wollongong Local Environmental Plan 2009 to identify 21 lots at Otford and Helensburgh on the Land Reservation Acquisition Map as Local Open Space, should proceed subject to the following conditions:

1. Maps prepared in accordance with the Department's 'Standard technical requirements for LEP maps' are to be exhibited with the proposal.

- 2. Community consultation is required under sections 56(2)(c) and 57 of the Environmental Planning and Assessment Act 1979 ("EP&A Act") as follows:
- (a) the planning proposal is to be made publicly available for 28 days; and
- (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A guide to preparing local environmental plans (Department of Planning and Infrastructure 2013).
- 3. No consultation is required with public authorities.
- 4. No public hearing is required to be held into the matter under section 56(2)(e) of the EP&A Act. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example in response to a submission or if reclassifying land).
- 5. The timeframe for completing the LEP is to be 9 months from the week following the date of the Gateway determination.
