Alteration of Gateway Determination

Planning proposal (Department Ref: PP_2014_WINGE_007_00) to:

- a) Rezone Lot 1, DP 781256 from RE1 to R2 and amend the Lot Size Map to apply 700m² and remove it from the Land Acquisition Map,
- b) Rezone Part Lot 10, DP 597322 from RE1 to E2 and remove it from the Land Acquisition Map, and
- c) Rezone Lot 126, DP 263356 from RE1 to R2 and amend the Lot Size Map to apply 700m² and reclassify it from Community to Operational Land.

I, the General Manager, Southern Region, at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979* (the Act) to alter the Gateway determination dated 8 August 2014 for the proposed amendment to the Wingecarribee Local Environmental Plan 2010 (LEP) as follows:

1. Delete:

Condition [3] "The timeframe for completing the LEP is to be **12 months** from the week following the date of the Gateway determination."

2. Replace with:

A new condition [3] "The timeframe for completing the LEP is to be **18 months** from the week following the date of the Gateway determination."
