Planning Proposal PP_2015_GLOUC_001_00 – Alteration of Gateway Determination

I refer to your letter dated 29 June 2017 requesting deferral of the short-term holiday accommodation component from the planning proposal until after the NSW Government decides how it should be consistently regulated across the State.

I have determined as the delegate of the Minister, in accordance with section 56(7) of the *Environmental Planning and Assessment Act 1979*, to alter the Gateway determination dated 4 September 2015 to defer the short-term holiday accommodation component, so that Council can finalise the holding of public events component.

I have also decided to issue an amended written authorisation to exercise the Minister's plan making functions under section 59 of the *Environmental Planning and Assessment Act 1979* for the holding of public events component only. The Alteration of the Gateway Determination and revised written authorisation to Exercise Delegation are enclosed.

If Council wishes to reactive the short-term holiday accommodation component, it will be necessary to submit a revised planning proposal to the Department for approval. The Department will then advise whether it needs to be re-exhibited before requesting finalisation.

Alteration of Gateway Determination

Planning Proposal (Department Ref: PP_2015_GLOUC_001_00)

I, the Director Regions, Hunter at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(7) of the *Environmental Planning and Assessment Act 1979 ("the Act")* to alter the Gateway determination dated 4 September 2015 (as since altered) for the proposed amendment to the Gloucester Local Environmental Plan 2014 as follows:

1. Change the description of the Planning Proposal

from "to prescribe circumstances for the rental of dwellings as short-term holiday accommodation, and the holding of temporary events, to be treated as Exempt Development"

to "to introduce short-term holiday accommodation and the holding of public events provisions into the Gloucester Local Environmental Plan 2014 in two stages. The short-term holiday accommodation component will be deferred until the NSW Government decides how short-term holiday accommodation should be consistently regulated across the State."
