Subject Planning Proposal to amend Canterbury LEP 2012 and Reclassification of Land at 15 Close Street, Canterbury

I am writing to you to advise that on 26 June 2014, Council resolved under Section 54(4) of the *Environmental Planning and Assessment Act, 1979* to prepare an amendment to Canterbury LEP 2012 to rezone land located at 15 Close Street, Canterbury. In doing so, Council also resolved to reclassify the site from Community land to Operational land under the Local Government Act, 1993.

The intention of the Planning Proposal is to:

- Rezone the site from RE1 Public Recreation to R4 High Density Residential;
- Introduce a range of maximum building heights (11.5 metres 26 metres), and a maximum FSR of 2.4:1;
- require a minimum 1,250m² of '*community facility*' uses to be provided on site; and
- permit 'restaurant or café' as an additional permitted use.

Council has commissioned a team of specialist consultants to prepare a Planning Proposal for the site, and is submitting this for a Gateway Determination as set out in Sections 55 and 56 of the *Environmental Planning and Assessment Act, 1979*. As required by Clause 9 of the *Environmental Planning and Assessment Regulation, 2000*, please find enclosed:

- A copy of the report to Council and minutes. Please note that as the land is owned by Council, the matter was considered in a closed session and accordingly it is requested the Council report and minutes remain confidential;
- A copy of the Planning Proposal and supporting documents prepared by the specialist team;
 Copies of relevant maps.
