## Subject Planning Proposal to amend Canterbury LEP 2012 and Reclassification of Land at 15 Close Street, Canterbury

I am writing to advise that on 25 June 2015, Council resolved to refer the draft Planning Proposal for 15 Close Street, Canterbury to the Minister with a request that the proposal be made as a local environmental plan under Section 59(2) of the Environmental Planning and Assessment Act 1979. In doing so, Council also resolved to request that the site be reclassified from Community land to Operational land under the Local Government Act 1993.

In support of the submission, please find enclosed:

- A copy of the Gateway determination dated 24 September 2014;
- A copy of the report to Council and minutes and attachments (planning proposal, public hearing report and DCP amendment) for the Council meeting dated 28 May 2015;
