Port Stephens Local Environmental Plan 2013

Report requesting the making of amending local environmental plan under Part 3 and section 73A of the *Environmental Planning and Assessment Act 1979*.

Background:

Port Stephens Council resolved to on 24.10.17 to amend the *Port Stephens Local Environmental Plan 2013* and to request the Minister for Planning make the plan under section 73A of the *Environmental Planning and Assessment Act 1979* (delegated decision attached).

The draft amending maps are attached.

The relevant land to which this amendment applies is 100 Salamander Way, Salamander Bay, legally known as Lot 21/DP1044009 and Lot 23/DP1044009.

Why there is a need for the amendment:

The proposed amendment is required to make a minor adjustment to the boundary of the E2 Zone to ensure consistency with the boundary of a registered BioBanking Agreement that applies to the relevant land (BioBanking ID Number 158, registered on 17 November 2015).

The minor discrepancies between the boundary of the BioBanking Agreement and the land zoned E2 prevent the retirement of the credits under the Agreement (See Section 127ZJ(a) of the *Threatened Species Conservation Act 1995* which continues to apply to the BioBanking Agreement and will apply to any BioBanking Statement prepared).

The BioBanking Agreement was prepared and registered by the Office of Environment and Heritage on 17 November 2015 following extensive site surveys and investigations, which more accurately identified the boundary of the relevant land than the zoning boundaries which were prepared prior to that Agreement.

What the amendment does:

Seeks to correct a mapping anomaly. The amendment will make a minor adjustment to the zone boundary to ensure consistency with a registered BioBanking agreement over the land.

0.11ha of E2 zoned land affected by the Biobank Agreement will be converted to the SP2 zone. 0.15ha of SP2 zoned land will become E2 zoned land as a result of the zone boundary adjustment. Overall, the zone boundary adjustment will increase the amount of land that is currently zoned E2 on Lot 21/DP1044009 and Lot 23/DP1044009.

Why the amending plan is suitable to be made in accordance with section 73A:

It will correct an obvious error that is considered of minor nature. The amendment would not result in any adverse effect on the surrounding land.






Site ID Map
