Planning proposal to amend Shoalhaven Environmental Plan 2014

I am writing in response to Council's request for a Gateway determination under section 56 of the *Environmental Planning and Assessment Act 1979* (the Act) in respect of the planning proposal to amend the Shoalhaven LEP 2014 to permit animal boarding or training establishment on Lot 1 DP227233, 19 BTU Road Nowra Hill.

As delegate of the Minister for Planning, I have now determined the planning proposal should proceed subject to the conditions in the attached Gateway determination.

In issuing this Gateway determination, I have found that the planning proposal is consistent with the s117 Directions 5.1 Implementation of Regional Strategies and 6.3 Site Specific Provisions. No further approval is required in relation to these or other Directions, while the proposal remains in its current form.

Council is to consult with the NSW Rural Fire Service prior to undertaking community consultation in order to satisfy the s117 Direction 4.4 Planning for Bushfire Protection and update the planning proposal accordingly.

Plan making powers were delegated to councils by the Minister in October 2012. It is noted that Council has not requested to be issued with delegation for this planning proposal. I have considered the nature of Council's planning proposal and have decided to issue an authorisation for Council to exercise delegation to make this plan. The proposal is of local significance and can be progressed in accordance with the Best Practice Guideline for LEPs and Council Land.

The amending Local Environmental Plan (LEP) is to be finalised within 12 months of the Gateway determination. Council should aim to commence the exhibition of the planning proposal as soon as possible. Council's request to draft and finalise the LEP should be made directly to Parliamentary Counsel's Office 6 weeks prior to the projected publication date. A copy of the request should be forwarded to the Department of Planning and Environment for administrative purposes.

The State Government is committed to reducing the time taken to complete LEPs by tailoring the steps in the process to the complexity of the proposal, and by providing clear and publicly available justification for each plan at an early stage. In order to meet

- I, Linda Davis, Acting General Manager, Southern Region at the Department of Planning and Environment as delegate of the Minister for Planning, have determined under section 56(2) of the *Environmental Planning and Assessment Act 1979* (the Act) that an amendment to the *Shoalhaven Local Environmental Plan 2014* to permit animal boarding or training establishment on Lot 1 DP227233, 19 BTU Road, Nowra Hill should proceed subject to the following conditions:
 - 1. A bushfire assessment report is to be prepared and included in the exhibition material.
 - 2. Prior to undertaking public exhibition, the planning proposal is to be updated to reflect the additional information provided by Council on 8 February 2016.
 - 3. The Land Zoning map exhibited with the planning proposal is to reflect that it is proposed to add "animal boarding or training establishment" as a permitted use on the site.
 - 4. Community consultation is required under sections 56(2)(c) and 57 of the *Environmental Planning and Assessment Act 1979* as follows:
 - (a) the planning proposal is to be made publicly available for a minimum 28 days; and
 - (b) the relevant planning authority must comply with the notice requirements for public exhibition of planning proposals and the specifications for material that must be made publicly available along with planning proposals as identified in section 5.5.2 of A Guide to Preparing local environmental plans (Department of Planning and Infrastructure 2012).
 - 5. Consultation is required with the following government agencies prior to exhibition, in accordance with the Act and to comply with the requirements of relevant s117 Directions
 - NSW Rural Fire Services and
 - Environmental Protection Authority.

The agencies are to be provided with a copy of the planning proposal and any relevant supporting material and given at least 21 days to comment on the

- proposal. Any agency advice received and council's proposed response to this advice should be placed on public exhibition with the planning proposal.
- 6. No public hearing is required to be held into the matter under section 56(2)(e) of the *Environmental Planning and Assessment Act 1979*. This does not discharge Council from any obligation it may otherwise have to conduct a public hearing (for example in response to a submission).
- 7. The timeframe for completing the LEP is to be 12 months from the date of the Gateway determination.
