Subject: Wingecarribee Local Environmental Plan 2010

Background:

Wingecarribee Shire Council resolved on 24 April 2013 to amend the Wingecarribee Local Environmental Plan 2010 under section 56 of the *Environmental Planning and Assessment Act 1979*.

The draft amending plan is attached.

The land to which this amendment applies is...16 Una Street, Bowral - Lot 42 DP911852

Why there is a need for the amendment:

Council exhibited the draft LEP map correctly, showing the subject land being rezoned from RE1 Public Recreation to R2 Low Density Residential. However, due to a request for changes to notations from the Department's mapping team when the maps were being finalised, an error was made on the subject map that inadvertently showed the subject land as R3 Medium Density Residential instead of R2 Low Density Residential.

Council's resolution was to rezone the land to R2 Low Density Residential and now seeks to correct the error made to the map.

What the amendment does:

The amendment will rectify the mapping error created under Wingecarribee Local Environmental Plan 2010 (Amendment No 25) to LZN_007F to change the zoning of Lot 42 DP911852 from R3 Medium Density Residential to R2 Low Density Residential, as per Council's resolution.

Why the amending plan is suitable to be made in accordance with section 73A:

The amendment corrects an obvious error in the principle instrument consisting of a misdescription on a map. The error was made after public exhibition and reporting to Council, but prior to the LEP being made.
