

**Public Notice – Public Exhibition of Planning Proposal –  
Schedule 5- Housekeeping Amendments to Local and State Heritage Listed Items**

Goulburn Mulwaree Council gives public notice of the public exhibition of a Planning Proposal under Schedule 1 Clause 4 of the *Environmental Planning and Assessment Act 1979*. The intended outcome of this Planning Proposal is to amend the *Goulburn Mulwaree Local Environmental Plan 2009 (GM LEP)* by updating the details of Local and State listed Heritage Items in Schedule 5: Environmental Heritage. Proposed updates seek to ensure item names, addresses and Lot and Deposited Plan numbers are accurate. In addition Heritage Items which currently have a combined listing have been separated and some boundaries of heritage items have been amended to more accurately reflect the extent of the items.

No new heritage items are proposed by this amendment and only heritage items demolished have been removed.

Goulburn Mulwaree Council is the delegated plan making authority for this planning proposal under the conditions of the gateway determination (available for viewing with the planning proposal).

**Exhibition details:**

The planning proposal and supporting information will be on public exhibition from **Friday, 23 April, 2021 until close of business Monday, 24 May, 2021**. It will be available to view at the Civic Centre (184 Bourke Street Goulburn), the Goulburn Mulwaree Library during business hours or online on the Goulburn Mulwaree Council web site [www.goulburn.nsw.gov.au](http://www.goulburn.nsw.gov.au) under the “Public Exhibition” section. Alternatively the planning proposal and supporting information is available to view on the NSW Government Planning Portal website [www.planningportal.nsw.gov.au/ppr](http://www.planningportal.nsw.gov.au/ppr), using reference PP-2021-2000.
