Planning Proposal: Revised Planning Proposal (PP-2021-2172) to allow for the development of seniors housing on 2 and 4 Nooal Street and 66 Bardo Road, Newport (being Lot 1 DP 540092, Lot 1 DP 315279 and Lot 2 DP 540092).

Purpose

To recommend the Director, as delegate of the Minister, determine that PP_2021_2172 to permit 'seniors housing' with development consent as an additional permitted use on land at 2 and 4 Nooal Street and 66 Bardo Road, Newport, should proceed to exhibition.

Revised Planning Proposal

In line with advice from the NSW Independent Planning Commission (IPC), Northern Beaches Council (Council) have submitted a revised planning proposal for review and approval prior to exhibition.

Council have written to the Department indicating that it will not be possible to comply with the timeframe for completing the LEP which will expire on 15 March 2021. As such, Council have requested an administrative withdrawal of the Planning Proposal and the re-submission of the Planning Proposal to allow the Department to issue a new Gateway Determination.

The revised Planning Proposal has been assessed against the Gateway Determination issued on 15 September 2020. It has been determined that the revised proposal addresses the majority of conditions detailed under Condition 1 of the Gateway Determination. However, as per condition 1(d) of the Gateway Determination, the revised proposal has failed to show all of the existing development standards that apply to the site.

A new Gateway Determination has been prepared with a minor condition requiring that prior to exhibition, the Planning Proposal is to be updated to include figure extracts showing all existing development standards that apply to the site. The Gateway Determination also includes a revised timeline to finalise the LEP.

Gateway determination

A new Gateway Determination has been prepared (Attachment B) with a minor condition requiring that prior to exhibition, the Planning Proposal is to be updated to include figure extracts showing all existing development standards that apply to the site. The Gateway Determination also includes a revised timeline to finalise the LEP.

Recommendation

That the Director, as delegate of the Minister:

- 1. Note the revised planning proposal (Attachment A);
- 2. Approve the revised planning proposal to enable public exhibition; and
- 3. Sign the attached letter to Council and Gateway Determination (Attachment B and C)
