Hello my name is Trudy and I lived with my husband at Hillcrest from around 1983 until 2017. We lived in Apartment 6 which was one of two apartments on the ground level with our own garden. Living at Hillcrest - the way it was when we purchased it in 1982/3, was probably the happiest time of my life. My daughter in her 20's was beginning her life away from home - and my husband and I moved from a larger house to a two bedroom apartment at Hillcrest. Actually - my husband and I used to sit in a park close by and watch as Hillcrest was restored to apartments back at that time. We would sit and look over this most beautiful building and watch it being painted in heritage colours and talk about the beauty of the building and surrounding landscape. We used to imagine what lives people had lead who lived there and make up our own little stories about it. Only later did we find out it was a part of a kindergarten back in the 1800's and attached to the convent (if I remember correctly - I'm 88 years old) In 1983 when we eventually moved in - it seemed all our neighbours in the adjoining apartments had the same views of the building as us - we loved it and wanted to care for it - we loved the ancient fig trees and the natural surrounds - this building back then was so appreciated. At that time I made it my personal mission to plant out the gardens that surrounded our unit. These were planted by me and my horticultural friends Rod and Mo, and I guess the idea (not so fashionable now) - was to plant using all sorts of English and exotic species - the area was verdant and full - everything was lush - and I hand watered the plants that needed me to help them on their journey to survive. The area was full of birds of all types - mainly little types of honeyeaters which thrived on the array of flowers that at some point in the year were always in bloom (If any one at Council would like to see pictures of the garden - I can provide them). But slowly over the years - our little group at Hillcrest moved on and different attitudes came to the fore about preservation. The beautiful old palms became what was called 'a nuisance' - the ancient fig was 'messy' and needed to go - grass needed to be grown to 'neaten' the look. Over time - the desire to change Hillcrest from what it was ... into a 'utilitarian' block of apartments came to the forefront. I have left Hillcrest - and the garden I once designed and tended has been concreted and rearranged. I have felt very sad over the years as I walk past Hillcrest and wonder what will become of it - a building with so much value and history - the idea now that it can be saved has given me some hope and thats why I'm writing this submission.
